
#### Investment focus

The fund's aim is to achieve capital growth in the long term, is actively managed and invests in healthcare stocks of companies that have their registered office or carry out the majority of their economic activity in the healthcare markets of the Asia-Pacific region. Its investment universe consists of generics producers, pharma and biotechnology companies, medical technology and services firms. Experienced sector specialists focus on profitable companies that have a well-established product portfolio. Investments are made based on fundamental research analysis. Stock selection is exclusively bottom up, independent of benchmark weightings. The fund takes ESG factors into consideration while implementing the aforementioned investment objectives.



#### Market review

Global stocks tacked on more gains last month. The MSCI World Index closed 2.7% higher month-on-month in USD. It seems like a Goldilocks scenario has taken center stage again. Economic data in the US suggests that economic activity, household consumption in particular, is holding up well without any signs of overheating. That, in turn, should not put any upward pressure on inflation. In the speech he gave at Jackson Hole, Fed Chair Jerome Powell flagged an initial rate cut for September 18, when the Fed's policy-making committee holds its next meeting. The market was also generally pleased with the latest company news, although some tech stocks were not quite as hot as in previous quarters, especially after making statements about their business outlook. Healthcare performed much better than the total market thanks not least to strong quarterly results from large-cap health stocks. The MSCI World Healthcare Index closed 5.5% higher mom. Asia-Pacific healthcare stocks performed even better, fueled once again by big gains in Japanese and Indian equities.

Chinese healthcare stocks also made pleasing gains, driven in part by strong quarterly results. Investors cheered the fast sales growth at Innovent, one of the fund's largest positions. Product sales revenue soared 55% in the latest quarterly reporting period compared to the same quarter in the previous year. Its checkpoint inhibitor that was recently approved in China as a treatment for numerous types of cancer was a major driver of this growth. Phase III data for its obesity drug is keenly awaited. Innovent is expected to release the data at the European Association for the Study of Diabetes (EASD) in September.

A large number of Chinese healthcare companies reported on business activity in the past quarter during the month under review and many medtech, generics and hospital companies conspicuously fell short of expectations. It appears that the extensive anti-corruption campaign the government launched last August is still casting a shadow over these subsectors within the healthcare system and has clearly put a damper on market activity. Contract manufacturers are also encountering headwinds due to geopolitical tension, so we have realigned our shareholdings in China again and sharpened the focus on innovation, especially in biotechnology.

Fisher & Paykel Healthcare delivered an excellent performance in August. The New Zealand-based medtech company's very positive guidance took investors by surprise. Fisher & Paykel said business was growing strongly across all products and regions. Management cited the successful launch of F&P 950 (respiratory humidifier) and Airvo 3 (respiratory support system) in the US this year, a continued high number of influenza hospital admissions, and the good uptake of the latest OSA masks (obstructive sleep apnea).

The fund's shareholdings of Sino Biopharmaceutical, Astellas and SK Biopharmaceuticals were increased during the past month. Positions in CSPC and Otsuka were trimmed. Hygeia and Cochlear are no longer in the portfolio.


#### **Positioning & outlook**

Asia is the most dynamic growth region in the world and it accounts for more than half of the world's population. Asian emerging markets are forecast to account for more than 50% of global GDP by 2050. As household incomes rise, the economic growth model of Asian countries will shift from manufacturing to the services sector. A growing middle class fuels demand for modern medicine. Healthcare ranks increasingly high on their wish list. Billions are being invested in infrastructure, technology and research to modernize the healthcare systems in emerging market countries. This is giving a greater swath of the population access to better healthcare. Meanwhile, rapid population aging is also stoking demand for healthcare. In 30 years there will be 400 to 500 mn people over 60 in China alone, and they will have a growing need for modern health services and medicines.

Japan, which has been referred to as "the world's demographic laboratory", has championed cutting-edge innovation for decades. The Land of the Rising Sun boasts technology leadership in numerous fields, ranging from therapeutic antibody technology, immunotherapy and robotics to digitalization, diagnostics and medical imaging systems. The fund offers defensive access to Asian emerging markets as well as exciting investment opportunities in technology leaders throughout the entire region. It invests in the entire healthcare system value chain, from generic drug producers and biotechnology companies to medical device manufacturers and digital health specialists.
