Swisscanto (LU) Portfolio Fund Responsible Ambition (EUR) AA is a unit class of the subfund Swisscanto (LU) Portfolio Fund Responsible Ambition (EUR) (hereinafter "fund"), a subfund in the umbrella fund Swisscanto (LU) Portfolio Fund. The fund is managed by Swisscanto Asset Management International S.A., Luxembourg.

Objectives and investment policy

The investment objective is to generate long-term capital growth and an adequate return in EUR by investing in shares and bonds worldwide.

Important features:

The fund invests in shares, bonds and money market instruments. The equities portion is between 40% and 85%. Up to 50% of the investments can be made indirectly (via target funds). The target funds are selected in accordance with the requirements set out in the prospectus. At least 2/3 of the investments are selected by systematically taking into account ESG criteria in accordance with responsibility requirements. The fund is classified under Art. 8 SFDR.

The securities are selected on a discretionary basis using a consistent investment process (active management). With regard to portfolio composition, the selection of stocks and the associated weightings are focused on companies from the tailored benchmark index.* The portfolio composition may deviate considerably from this benchmark index.

The investment policy is to outperform the benchmark index. The Asset Manager may at any time deviate – significantly or insignificantly, positively or negatively - from the benchmark index by actively overweighting or underweighting individual securities and sectors based on market conditions and risk assessments.

Derivatives may be used for achieving the investment objective.

Fund units will be issued or redeemed basically on any bank business day in Luxembourg.

Earnings and profits of the unit class are distributed.

Additional important information:

The total commitments of the fund may not amount to more than 210% as a result of the use of derivatives (max. 100%) and temporary borrowing (max. 10%).

Recommendation on holding period: this fund is appropriate for investors with a medium-term investment horizon (three to five years) or a longer-term investment horizon.


