The Fund pursues a long-biased fundamental equity strategy focused on European and US markets. Assets are predominately invested in companies with a proven track record of compounding cash flow or earnings over sustained periods of time. Hedging techniques will be applied to cushion assets against higher volatility. The portfolio is managed with a 3- to 5-year time horizon and not managed in reference to a benchmark.

The portfolio ended December up 0.1%. The S&P 500 (EUR) declined by 0.4%, the MSCI World (EUR) by 0.6%, the Nasdao 100 (EUR) increased by 2.5%, and the Stoxx 50 (EUR) increased by 0.3% during the period.

US equities were mostly lower after an exceptional monthly performance in November. Strong performance by Big Tech masked underperformance of smaller sized companies. The eoual weighted SPX underperformed the SPX by 410 bps and the Russell 2000 gave up most of its 10.8% gain made in November. Tesla (+17%) and Alphabet (+12% after quantum computing newsflow) were standout performers.

December was light on company specific news. The FOMC meeting was the anticipated event during the month. As expected, rates were cut by 25bps but a hawkish tone served as a reminder that "higher for longer" is still in the cards. The market is now pricing a 90% chance of no rate cut at the lanuary meeting.

2024 was by all accounts another extraordinary year for global indices. The S&P 500 recorded back-to-back >20% performance for the first time since 1998. Similarly to 2023, performance was not evenly distributed. The equal weight S&P 500 clocked in at 11.1% while the S&P 500 was up 23.3%. Nvidia (+171%) continued its remarkable 2023 run and Tesla (+62.5%) appears to make substantial inroads with its full self-driving technology.

The US presidential election provided substantial fuel to this year's rally in the fourth quarter. If the president elect makes good on his election promises of deregulation, tax cuts for individuals and corporations, earnings growth as the key driver of sustainable equity index performance, could surprise to the upside. However, prolonged inflation and higher bond yields could potentially outweigh the aforementioned positive impacts. In stark contrast to 2016, the president elect is currently riding on a popularity wave. Nevertheless, it will be impossible to please everybody. For now, majorities in the House and Senate will allow him to flex regulatory muscle. Global geopolitical and economic relations will be put to the test once more. We deem it wise to ignore the constant tweets and newsflow. That said, the impact on selected players could have dramatic revenue and earnings impacts.

Top contributors were Alphabet (61 bps), Tesla (35 bps), and Apple (27 bps). Top detractors were Apollo Global (64 bps), Nu Holdings (56 bps) and the China Internet ETF (49 bps).
