



Global fixed income markets ended the month higher despite periods of volatility. Treasury yields initially rose on the back of Trump's victory, but later declined as the focus shifted to the Fed's rate trajectory. In Europe, weakerthan-expected inflation and PMI data weighed on the growth outlook, pushing government bond yields and the euro lower.

### Monthly performance

In November the fund performed positively with 0.9%. High carry and tightening spreads drove total returns into positive territory.

### YTD performance

YTD as of the end of November, the fund has delivered a positive performance of 9.1%. High levels of income and tighter spreads across global developed high-yield markets have been the primary drivers of returns. Higher interest rates in some markets have also contributed given the floating-rate nature of the strategy.

### **Performance contributors**

Credit rated B outperformed other credit qualities. US high yield outperformed EUR high yield this month. By industry, leisure, telecommunications and diversified financial services were the top performers.

### **Performance detractors**

Credit rated CCC underperformed. By industry, air transportation, consumer products and governmentrelated issuers underperformed on a relative basis.

## Current investment strategy

We increased our exposure to credit rated BB, and the portfolio's average rating is now BB-. We added credit default swap exposure in order to adjust our duration positioning.
