

Global fixed Income markets made a positive start to 2025 as interest rates stabilised after a month of volatility. The Fed paused its rate cuts at the central bank's January meeting, while the ECB cut policy rates by 25bp and maintained its dovish guidance. Risk sentiment remained supported and drove the performance of credit spreads, despite tariff headlines.

Monthly performance

In January the fund performed positively with 0.2%. Lower government bond yields, tightening spreads and high income drove total returns into positive territory.

YTD performance

YTD as of the end of January, the fund has delivered a positive performance of 0.2%. Please refer to the section above.

Performance contributors

The allocations to investment grade and high-yield bonds outperformed other markets. By market, the allocations to issuers in the US, UK and Japan were the top performers.

Performance detractors

Almost all sectors delivered positive returns in January. China's property sector underperformed on a relative basis. By market, allocations to issuers in China, Singapore and Egypt underperformed.

As the strategy has a fixed maturity, we generally aim to buy and hold issues until maturity. There were no material changes to positioning during the month.
