

Global fixed income markets ended the month higher despite periods of volatility. Treasury yields initially rose on the back of Trump's victory but subsequently fell as the focus returned to the Fed's rate trajectory. In Europe, weaker-than-expected inflation and PMI data weighed on the growth outlook, pushing government bond yields and the euro lower.

Monthly performance

In November the fund performed positively with 0.3%. Lower government bond yields and high income sent performance into positive territory.

YTD performance

YTD as of the end of November, the fund has delivered a positive performance of 4.3%. Tightening global credit spreads since year-end along with attractive carry have been the primary drivers. Rising government bond yields in some markets since yearend have only partially eroded returns.

Performance contributors

The allocations to investment grade and emerging markets bonds outperformed other markets. By market, the allocations to issuers in the US, UK and Ireland were the top performers.

Performance detractors

Almost all sectors delivered positive returns in November. EUR-denominated investment grade bonds underperformed on a relative basis. By market, allocations to issuers in Luxembourg, Singapore and the Dominican Republic underperformed.

As the strategy has a fixed maturity, we generally aim to buy and hold issues until maturity. There were no material changes to positioning during the month.
