

January saw a V-shaped rebound in Chinese equities. Major market drivers included the US-China relationship, domestic policy support and the latest technical breakthroughs in Al accomplished by China's DeepSeek.

Monthly performance

In January the fund performed positively with 0.8%. Initially, there was a sharp sell-off that was triggered by the addition of major companies to the US list of Chinese Military-Industrial Complex Companies (CMIC). The market subsequently staged a recovery ahead of the Lunar New Year as initial US-China tariff tensions proved to be more moderate than feared.

YTD performance

YTD as of the end of January, the fund has delivered a positive performance of 0.8%. Please refer to the section above.

Performance contributors

The most positive contributions stemmed from our holdings in communication services and consumer discretionary. NetEase and Alibaba Group were the key stock contributors over the month.

Performance detractors

Meanwhile, holdings in consumer staples and healthcare weighed on performance. Kweichow Moutai fell as expectations of policy stimulus moderated, as well as on concerns about the company's wholesale price amid weak consumer demand in China. However, we believe that the company's key advantages, which relate to its strong brand, distribution and pricing power, were not impaired.

Domestically, a clear pro-growth policy pivot should help to improve the growth outlook alongside gradual price momentum.
