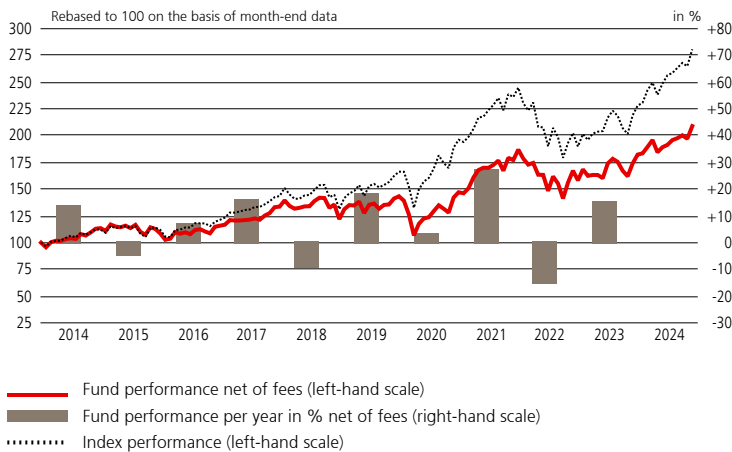
## Performance **Review**

UBS (Lux) Equity SICAV - US Total Yield Sustainable (USD) (CHF hedged) P-acc



**The US large cap equity market delivered a positive performance in November 2024, producing its best monthly return in 2024 to date. Equity markets rallied as the US elections went smoothly and a Republican sweep of the presidency and Congress boosted hope of a business-friendly environment.**

### Monthly performance

In November the fund performed positively with 6.0%. The fund outperformed the broad US stock market, mainly due to stock selection and low exposure to the healthcare sector.

### YTD performance

YTD as of the end of November, the fund has delivered a positive performance of 14.6%. The fund is lagging the broad US stock market, which is mainly due to its underweight in mega cap tech stocks and its exposure to smaller stocks in the index, as well as low-momentum stocks.

### Performance contributors

All sector exposures contributed to fund performance this month. At the stock level, the fund took advantage of holding McKesson, Apple and Deere & Co.

### Performance detractors

No sector exposures detracted from fund performance this month. At the stock level, the fund was negatively impacted by holding Qualcomm, Medtronic and Applied Materials.

We continue to follow our investment approach, investing in high total yield and high-quality stocks and holding a very well diversified and defensive portfolio across countries and sectors. We believe that these factors will add value to the portfolio over the mid to long term.
