

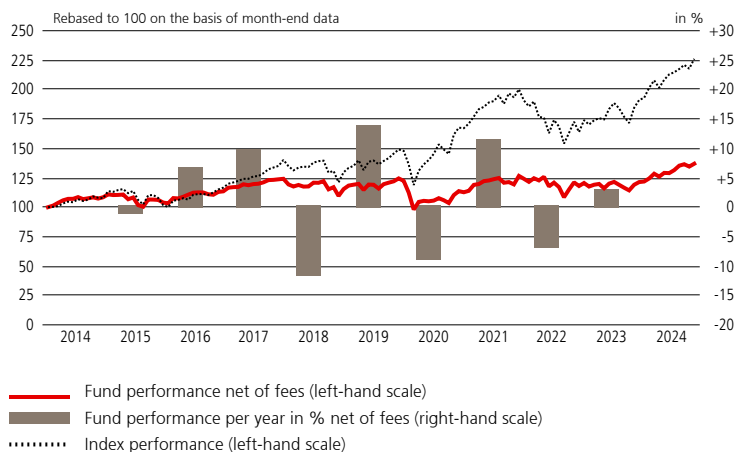

November was a strong month for global and US equities, which rallied to all-time highs as the US election outcome removed a key uncertainty and investors focused on the potential for pro-growth policies under the new administration. Chinese equities underperformed amid tariff concerns and stimulus disappointment.

Monthly performance

In November the fund performed positively with 1.8%. The positive performance in November was driven by global equity exposure and country selection. The exposure to companies with high book-to-price values added to performance over the month. Call overwriting detracted from performance.

YTD performance

YTD as of the end of November, the fund has delivered a positive performance of 12.8%. The exposure to stocks with high dividend and earnings yields, as well as high book-to-price values, have all been positive. The country and asset selections have also made favourable contributions.

Performance contributors

The fund's allocation to the US and Chinese equity markets, as well as its exposure to financials and telecommunication services, added value. At the stock level, the fund profited from ONEOK and Swiss Re.

Performance detractors

Meanwhile, the fund's allocations to the Japanese and Italian equity markets, as well as its exposure to information technology and materials, detracted from performance. The fund suffered due to its stakes in Dow and Yutong Bus.

We continue to follow our investment approach, investing in high-dividend and high-quality stocks and holding a very well-diversified and defensive portfolio across countries and sectors. We believe that these factors will add value to the portfolio over the mid to long term.
