

Global and US stocks weakened in February amid concerns over the potential for higher tariffs, resurgent worries about stagflation in the US, and a more cautious stance on the outlook for Al. European equities surged to an all-time high, fuelled by the anticipation of increased fiscal spending on defence.

Monthly performance

In February the fund performed positively with 1.9%. The positive performance in February was driven by risk styles, stock selection, country and industry allocations. The exposure to defensive companies with low beta and volatility, as well as to names with high leverage, added to performance over the month. Call overwriting detracted from performance.

YTD performance

YTD as of the end of February, the fund has delivered a positive performance of 3.8%. The exposure to defensive companies with low beta and volatility has been favourable. Asset selection and the country allocation have also contributed positively.

Performance contributors

The fund's allocations to the Italian and the Taiwanese equity markets, as well as its exposure to financials and real estate, added value. At the stock level, the fund profited from Gilead Sciences and AT&T.

Performance detractors

The fund's allocations to the US and Indian equity markets, as well as its exposure to energy and consumer discretionary, detracted from performance. The fund suffered due to its stakes in Qualcomm and Yutong Bus.
