



3 Reference Index in currency of share class (without costs)

The fund delivered a positive performance in USD in August 2024 against the backdrop of a positive showing by the US large cap equity market. Markets fell at the beginning of August due to economic growth concerns, only to rebound over the remainder of the month as growth prospects stabilised and Fed rate cuts moved back on to the horizon.

Monthly performance

In August the fund performed positively with 1.4%. The fund lagged the broad US stock market due to its low-beta tilt, its overweight in value stocks and its underweight in high-momentum stocks.

YTD performance

YTD as of the end of August, the fund has delivered a positive performance of 7.7%. The fund is lagging the broad US stock market due to poor stock selection, its low-beta tilt, the covered call overlay and its underweight in high-momentum stocks.

Performance contributors

The consumer staples, healthcare and financials sector exposures contributed to fund performance this month. At the stock level, the fund profited from holding HCA Healthcare, Cardinal Health and General Mills.

Performance detractors

The energy and consumer discretionary sector exposures detracted from fund performance this month. At the stock level, the fund was negatively impacted by holding McKesson, Chevron and NetApp. The call overlay also detracted.

We continue to follow our investment approach, investing in high total yield and high-quality stocks and holding a welldiversified and defensive portfolio across countries and sectors. We believe that these factors will add value to the portfolio over the mid to long term.
