

January saw significant challenges including a halt to Fed rate cuts, aggressive tariffs from the new Trump administration and concerns over US tech competitiveness due to DeepSeek launching a low-cost AI model. This led to a historic decline in Nvidia's stock and losses in US tech and energy stocks towards month-end.

#### Monthly performance

In January the fund performed positively with 0.2%. The fund was able to take advantage of the solid performance of most bond markets.

#### **Current investment strategy**

Over the month, we opened a long position in UK 10-year versus French 10-year government bonds. Meanwhile, we kept our position in 5-year US Treasuries versus cash and 30year US Treasuries. Currency-wise, we retained our overweight in the USD against an underweight in the CNY, while we opened a long JPY versus CHF position.
