



January saw significant challenges including a halt to Fed rate cuts, aggressive tariffs from the new Trump administration and concerns over US tech competitiveness due to DeepSeek launching a low-cost AI model. This led to a historic decline in Nvidia's stock and losses in US tech and energy stocks towards month-end.

Monthly performance

In January the fund performed positively with 2.4%. The fund was able to take advantage of the significant gains in equity markets, with the European and Swiss markets displaying strong performances. The bond segment and alternative assets also delivered positive returns.

YTD performance

YTD as of the end of January, the fund has delivered a positive performance of 2.4%. Please refer to the section above.

Performance contributors

Both equities and fixed income performed well, with equities leading the way thanks to positions in the US, European and Swiss markets. In fixed income, high-grade and emerging market government bonds were the main contributors. Hedge funds also made a positive contribution.

Current investment strategy

During January, the fund maintained a high equity allocation and a long duration stance, targeting a duration of six years within the high-grade space.
