

YTD: year-to-date (since beginning of the year) Macro data published in August dispelled fears of an imminent recession following weakerthan-expected data releases in July. Equities and fixed income finished higher after short-lived market turmoil at the beginning of the month.

Monthly performance

In August the fund performed positively with 1.3%. Global equities gained over the course of August despite significant intra-month volatility. A cooling labour market and slowing inflation pushed US Treasury yields lower. Credit spreads tightened, heading back towards cyclical lows.

YTD performance

YTD as of the end of August, the fund has delivered a positive performance of 8.4%. The momentum surrounding AI continues to slow amid a shift in sectoral leadership away from expensive tech stocks. Fixed income markets are still pricing in increased chances of consecutive rate cuts by the Fed.

Performance contributors

Equities and fixed income contributed to the positive performance. US equities and global high-dividend stocks drove equity performance, while Australian, European and UK equities also added value. In fixed income, US investment grade and US high-yield credit were the main contributors.

Performance detractors

The fund's covered call strategy detracted from performance amid sharply rising equity markets.

Current investment strategy

With signs that inflationary pressures are abating and growth is weakening, major central banks appear ready to pause their hiking cycles to assess the full effects of policy tightening. Against this backdrop, we see the yields offered by high-grade bonds as an attractive source of income.
