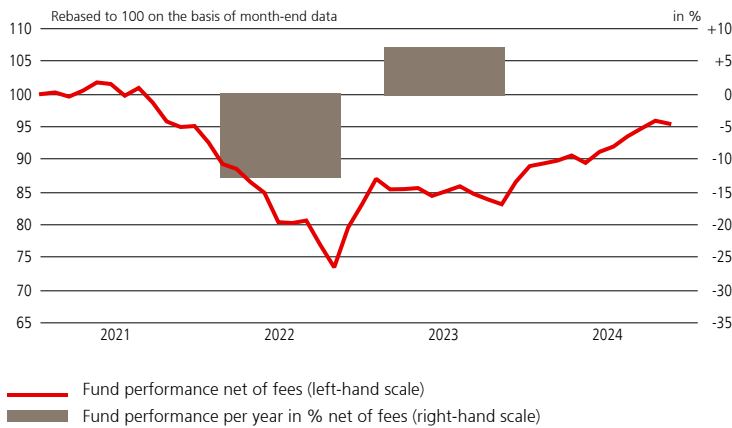
## Performance **Review**

**Global fixed income markets posted largely negative returns in October as investors repriced expectations of policy easing by the Federal Reserve. Jobs data came in mostly stronger than expected, suggesting that the Fed is in no rush to cut aggressively.**

### Monthly performance

In October the fund performed negatively with 0.5%. Fixed income returns were broadly negative in October as US Treasuries sold off.

### YTD performance

YTD as of the end of October, the fund has delivered a positive performance of 7.3%. The fund has performed well on a year-to-date basis, with good contributions from all allocations.

In October, Asia and China high yield, EUR high yield and Chinese onshore bonds contributed to performance.

## Current investment strategy

The fund provides investors with a diversified credit portfolio that has a strategic bias towards Asian credit, together with a unique allocation to onshore China bonds, which acts as a diversifier. We seek to manage through this volatile environment via active management and diversification.

## Risks
