

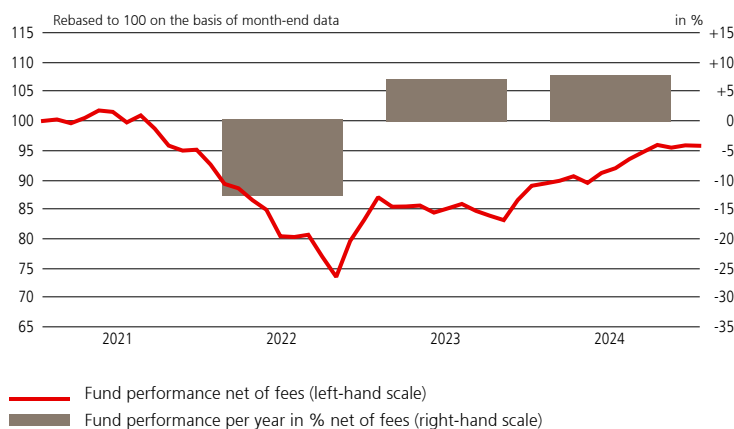

**Markets ended the year in a more cautious mood as investors scaled back expectations for the Federal Reserve's pace of rate cuts after a hawkish December policy meeting. Fixed income markets ended a volatile year on a weak note. The yield on the 10-year US Treasury, which started the year at 3.88%, ended 2024 at 4.57%.**

### Monthly performance

In December the fund performed negatively with 0.1%. Fixed income returns were broadly negative in December as US Treasuries sold off.

### YTD performance

YTD as of the end of December, the fund has delivered a positive performance of 7.6%. The fund performed well on a full-year basis, with good contributions from all allocations.

### Performance contributors

In 2024, all allocations within the fund contributed to a strongly positive performance.

### Performance detractors

There were no allocations that detracted over the past year.

## Current investment strategy

The fund offers investors a diversified credit portfolio with a strategic bias towards Asian and emerging market credit, together with a unique allocation to onshore China bonds that acts as a diversifier. We seek to manage through this volatile environment via active management and diversification.

## Risks
