## What is this product?

### Type

Tower Investment Grade Bond Fund (the "Fund") is a sub-fund of Diamond Capital Funds plc (the "Company") which is an open-ended umbrella investment company with variable capital and segregated liability between sub-funds, registered in Ireland and established as a UCITS.

### Objectives

**Investment objective** The investment objective of the Fund is to provide long-term capital appreciation.

**Investment policies** The Fund seeks to achieve its investment objective by investing primarily in a globally diversified portfolio of fixed and/or variable rate investment grade debt or debt-related securities issued by governments, their agencies or corporations. The term 'investment grade' covers debt or debt-related securities for which a rating ranging from AAA to BBB- has been granted by at least one recognised credit rating agency (Standard and Poor's or equivalent rating) or which, in the Investment Manager's opinion, are of comparable quality.

The Fund may also invest up to 10% of its net assets in other collective schemes.

The Fund will primarily invest in securities which are investment grade and may invest more than 20% of its net assets in countries that the Investment Manager regards as emerging markets.

In order to achieve the Fund's investment objective, the Fund may also invest in credit default swap indices.

The Fund may use currency forwards for the purposes of hedging.

Investment of up to 100% of the Fund's net assets may also, in certain circumstances, be made in fixed or floating rate government debt securities which are rated investment grade and in money market instruments and cash deposits. Investment in OECD government debt securities may include up to 100% of the Fund's Net Asset Value in different issues of the one issuer. The Fund may hold such investments for cash management and other ancillary purposes.

**Benchmark** The Fund is actively managed without reference to any benchmark meaning that the Investment Manager has full discretion over the composition of the Fund's portfolio, subject to the stated investment objectives and policies.

**Redemption and Dealing** Shares in the Fund can generally be bought and sold daily (i.e. every Business Day of the Fund). Please refer to the Prospectus for more information.

**Distribution Policy** This Share Class distributes its income.

**Launch date** The Fund was launched on 01/03/2017. The share class was launched on 01/03/2017.

**Fund Currency** The base currency of the Fund is USD.

**Conversion of units/shares** Subject to the Minimum Initial Subscription, Minimum Holding and Minimum Transaction Size requirements of the relevant Classes, Shareholders may request conversion of some or all of their Shares in one fund of the Company or Class to Shares in another fund of the Company or Class or another Class in the Fund in accordance with the procedures specified in the Prospectus under the heading "Conversion of Shares".

**Asset Segregation** The Fund is a sub-fund of the Company, an umbrella fund with segregated liability between sub-funds. You can find out more information about the umbrella fund in the Prospectus. The Prospectus and periodic reports are prepared in the name of Company.

### Intended retail investor

This product is intended for investors who plan to stay invested for at least 3 years and are prepared to take on a low level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

### Term

The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. The PRIIP manufacturer, Waystone Management Company (IE) Limited, is not entitled to terminate the product unilaterally.

**Depositary** The depositary of the Fund is Northern Trust Fiduciary Services (Ireland) Limited.

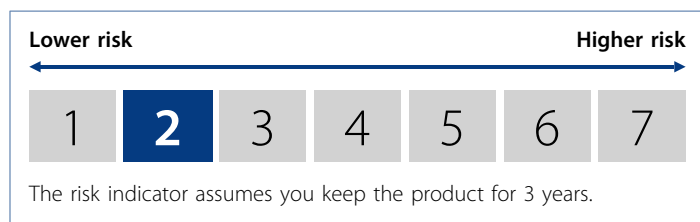

## What are the risks and what could I get in return?

### Risk Indicator

## What happens if Waystone Management Company (IE) Limited is unable to pay out?

The Management Company has no obligation to pay out since the Fund design does not contemplate any such payment being made. You are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depository. Should the Fund default, the depository would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 USD is invested.
