

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

A CHF (IE00BF559C90) is a share class of Sturdza Family Fund (the "Fund") which is a sub-fund of E.I. Sturdza Funds PLC (the "UCITS"). The UCITS is authorised in Ireland. **PRIIPs Manufacturer:** Eric Sturdza Management Company S.A. (the "Manager") whose website is www.ericsturdza.lu. Call +352 28 99 19 10 for more information. The Manager has been appointed as an external Management Company to the UCITS. The Commission de Surveillance du Secteur Financier (CSSF) is responsible for supervising the Manager in relation to this Key Information Document. The Manager is authorised in Luxembourg and regulated by the CSSF **Date of Production:** 13 September 2024.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

A CHF is a share class of the Fund which is a sub-fund of the UCITS, an open-ended umbrella investment company comprising a number of different sub-funds. The assets of the Fund are segregated from other sub-funds in the umbrella structure which means that your investment in the Fund will not be affected by any claims made against any other sub-fund of the UCITS. Investors may switch their shares in the Fund for shares in a different currency class or for shares within another sub-fund in the umbrella structure. Term

There is no fixed term for the UCITS.

Objectives

The Manager has appointed E.I. Sturdza Strategic Management Limited (the "Investment Manager") who manages the Fund with the objective of achieving capital appreciation over the long term. In order to achieve its investment objective the Fund will invest directly, or indirectly through the use of financial derivative instruments (as detailed below), primarily in equities, equity related instruments (such as common stock and preferred stocks) and fixed income securities on a global basis, which shall be listed or traded on a Recognised Exchange.

The Fund's exposure to equities and equity related instruments (excluding via Financial Derivative Instruments) will be 51% to 80% of the Fund's Net Asset Value (the Fund will continuously invest at least 51% of its total assets in equities of corporations which are admitted to official trading on a stock exchange or which are listed on an organised exchange), whilst the fixed income exposure will be limited to 20%-49% of the Net Asset Value. The aggregate exposure to equities, equity related instruments (excluding via Financial Derivative Instruments) and fixed income issued by companies incorporated or whose principal operations are based in the United States or issued by the US Government shall be at least 50% of the Fund's NAV.

The Fund will seek to invest in equity securities of companies that are expected to grow at a faster rate than their peers, whilst fixed income exposure will be achieved by investing in Sovereigns, Supranationals and Agencies (together 'SSAs'), corporate bonds with a minimum credit rating

of Ba1/BB+, or equivalent and a minimum issue size (i.e. the initial amount issued and the amount outstanding) of USD 400 million, or equivalent currency. Investments in Corporate bonds will include, corporate hybrid bonds, which are essentially a mixture of debt and equity and TIER2 bonds, i.e. subordinated bonds with fixed maturity and coupons subordinated to senior debt. When investing in bank debt, the Fund is only permitted to invest in Tier 2, thus excluding investments in deeply subordinated bank debt.

The Investment Adviser retains the flexibility to invest substantially in cash and/or money market or short-dated instruments.

Pursuant to the EU's Sustainable Finance Disclosure Regulation (EU) 2019/2088 ('SFDR'), this Fund is classified as an Article 8 fund that promotes environmental or social characteristics. The Fund will have an averaged ESG score higher than the averaged ESG score of its initial investment universe.

The Investment Manager is free to choose how the Fund is invested within the limits of its investment policy.

You can buy and sell your shares in the Fund on a daily basis.

The Shares that you will hold in the Fund are accumulating, meaning that the income from the Fund's investments will be included in the value of your shares rather than being paid as a dividend.

Intended retail investor

The Fund is deemed to be appropriate for investors who plan to invest for the medium to long term.

The Fund is actively managed, with reference to the 60 % Morningstar Developed Markets Target Market Exposure NR USD + 20 % Secured Overnight Financing Rate (USD) + 20 % Bloomberg US Aggregate Government/Credit Total Return Value unhedged USD (the "Index") for performance monitoring and calculation of performance fees (where applicable).

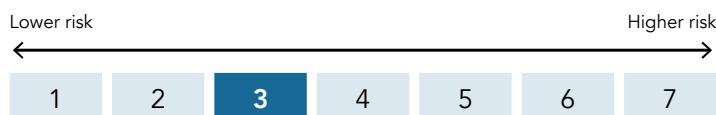

What are the risks and what could I get in return?

Summary Risk Indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.



The risk indicator assumes you keep the product for a minimum of 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of Eric Sturdza Management Company S.A. to pay you.

The risk indicator is based on historical data and may not be a reliable indicator of the future risk profile of the Fund, is not guaranteed and may change over time. The lowest category does not mean risk free. The risk indicator for the Fund reflects the historic price behaviour of the Fund.

Factors that affect the risk profile of the Fund include:

How long should I hold it and can I take money out early?

Recommended Holding Period: 5 Years

The Fund offers daily liquidity to investors, as such subscriptions and redemptions can be processed on a daily basis. There are no lock up periods or penalties associated with redeeming a holding prior to the recommended holding period.

The Fund has been assessed as being suitable for mid to long term investors as a result of the concentrated and directional nature of the investment portfolio. This means that the Fund will hold a different exposure mix compared to the 60 % Morningstar Developed Markets Target Market Exposure NR USD + 20 % Secured Overnight Financing Rate (USD) + 20 % Bloomberg US Aggregate Government/Credit Total Return Value unhedged USD (the "Benchmark"), wider market and peers, and it is possible that at different parts of the markets cycle that the maintained positioning will benefit or be negatively impacted. As such, investors holding an investment for a short time frame may not benefit from the exposure offered by the Fund.
