This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

USD Private (LU1369535247) is a share class of VIA Alternative-Liquid (the "Fund") which is a sub-fund of VIA AM SICAV (the "UCITS"). The UCITS is authorised in Luxembourg. **PRIPs Manufacturer:** Eric Sturdza Management Company S.A. (the "Manager") whose website is www.ericsturdza.lu. Call +352 28 99 19 10 for more information. The Manager has been appointed as an external Management Company to the UCITS and is authorized in Luxembourg and regulated by the Commission de Surveillance du Secteur Financier ("CSSF"). The CSSF is responsible for supervising the Manager in relation to this Key Information Document. **Date of Production:** 21 January 2023.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

USD Private is a share class of the Fund which is a sub-fund of the UCITS, an open-ended umbrella investment company comprising a number of different sub-funds. The assets of the Fund are segregated from other sub-funds in the umbrella structure which means that your investment in the Fund will not be affected by any claims made against any other sub-fund of the UCITS. Investors may switch their shares in the Fund for shares in a different currency class or for shares within another sub-fund in the umbrella structure. For further information please refer to the Fund's supplement.

Term

There is no fixed term for the UCITS.

Objectives

The Manager has appointed VIA Asset Management (the "Investment Manager") who manages the Fund with the objective of achieving long-term capital growth.

VIA Alternative Liquid is a systematic multi-asset, multi-strategy UCITS fund. The strategy selects a diversified basket of absolute return systematic sub-strategies such as US Equity Long/Short, Europe Equity Long/Short, Momentum Multi-Asset, FX Carry Trade, Interest Rate Slope... Each sub-strategy has its own risk budget with a strict weight constraint in order to limit potential losses.

The fund invests in listed securities or derivatives, but also in OTC derivatives such as index swaps.

The strategy aims to outperform its benchmark, or its equivalent in the unit's currency, with a maximum loss of -10% over 12 months under normal market conditions.

Pursuant to the EU's Sustainable Finance Disclosure Regulation (EU) 2019/2088 ('SFDR'), this Fund is classified as a fund that promotes environmental or social characteristics.

The Investment Manager is free to choose how the Fund is invested within the limits of its investment policy.

You can buy and sell your shares in the Fund on a daily basis.

The Shares that you will hold in the Fund are accumulating, meaning that the income from the Fund's investments will be included in the value of your shares rather than being paid as a dividend.

Intended retail investor

The Fund is deemed to be appropriate for investors who plan to invest for the medium to long term.

The Fund is actively managed, with reference to the Libor 3 months USD (the "Index") for performance monitoring and calculation of performance fees (where applicable).

The Depositary is The Bank of New York Mellon SA/NV, Luxembourg Branch.

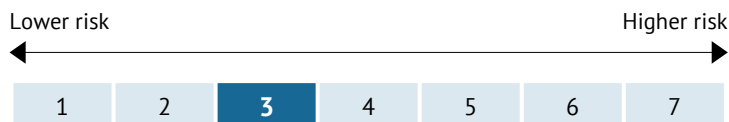

What are the risks and what could I get in return?

Summary Risk Indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.



The risk indicator assumes you keep the product for a minimum of 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of Eric Sturdza Management Company S.A. to pay you.

The risk indicator is based on historical data and may not be a reliable indicator of the future risk profile of the Fund, is not guaranteed and may change over time. The lowest category does not mean risk free. The risk indicator for the Fund reflects the historic price behaviour of the Fund.

Factors that affect the risk profile of the Fund include:

Investments in equity securities are subject to fluctuations in value dependent on market conditions which will directly affect the value of investments held by the Fund, whilst fixed income investments are subject to interest rate fluctuations which will directly affect the value of

investments held. Fixed income investments are subject to actual and perceived measures of issuers creditworthiness, which could alter their value and liquidity.

Some of the portfolio's securities may be noninvestment grade as determined by leading rating agencies and investments in corporate hybrid bonds are subject to a unique set of risks.

Counterparty Risk: the risk associated with holding assets with an unrelated third party who may fail to deliver the assets or whose financial standing may affect the value of the assets.

Liquidity Risk: the risk that the assets of the Fund may have low levels of liquidity in some circumstances.

You can buy and sell your shares in the Fund on a daily basis. How long should I hold it and can I take money out early?

Recommended Holding Period: 5 Years

The Fund offers daily liquidity to investors, as such subscriptions and redemptions can be processed on a daily basis. There are no lock up periods or penalties associated with redeeming a holding prior to the recommended holding period.

The Fund has been assessed as being suitable for mid to long term investors as a result of the concentrated and directional nature of the investment portfolio. This means that the Fund will hold a different exposure mix compared to the Libor 3 months USD (the "Benchmark"), wider market and peers, and it is possible that at different parts of the markets cycle that the maintained positioning will benefit or be negatively impacted. As such, investors holding an investment for a short time frame may not benefit from the exposure offered by the Fund.
