## What is this product?

#### Type

BKB Sustainable is a contractual umbrella fund under Swiss law of the type "Other funds for traditional investments" pursuant to the Swiss Federal Act on Collective Investment Schemes (CISA) of 23 June 2006.

#### Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

#### **Objectives**

This subfund is suitable for investors with a long-term investment horizon who are primarily aiming for growth in their invested capital. Investors are willing to accept greater price fluctuations and a longer-lasting decline in the net asset value of the fund shares. They are familiar with the risks of investing in shares. In addition to traditional financial ratios, environmental and social criteria are also included in the investment decision. After deducting liquid assets, the fund management company invests at least two-thirds of the subfund's assets in: equity securities and rights with a primary listing on the Swiss stock exchange (shares, profit certificates, cooperative shares, participation certificates and similar) Shares in other funds (target funds) with a comparable investment strategy. The upper limit is 10%. No benchmark index is used. The fund manager invests at his own discretion but within the specified investment restrictions.

The fund's return depends primarily on the development of the stock markets and the dividend payments.

The fund's income is added annually to the fund's assets for reinvestment (reinvestment).

#### Intended retail investor

This investment fund is suitable for professional investors as well as private investors with no or limited investment experience who are able to bear potential investment losses. This investment fund aims to grow in value and meets the requirements for sustainable investments, and under normal market conditions allows daily access to invested capital. It meets medium-term investment requirements.

## What happens if UBS Fund Management (Switzerland) AG is unable to pay out?
