What is this product?

Type

BKB Sustainable is a contractual umbrella fund under Swiss law of the type "Other funds for traditional investments" pursuant to the Swiss Federal Act on Collective Investment Schemes (CISA) of 23 June 2006.

Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

This sub-fund is suitable for investors with a medium-term investment horizon who are looking for regular income but only want to enter into limited risk. Investors must be prepared to accept temporary fluctuations in the value of fund units. They must be familiar with the risks associated with bonds and similar securities. Environmental and social criteria are incorporated into investment decisions alongside traditional financial metrics. The fund management company invests at least two-thirds of the sub-fund's assets, after deduction of liquid assets, in: Bonds, notes and other fixed or floating-rate debt securities and rights of private issuers worldwide, denominated in freely convertible currencies. Investment decisions are made following analysis of environmental, social and financial metrics and of the quality of the companies' governance. Units in other funds (target funds) with comparable investment strategies. The upper limit is 10%. There is no benchmark. The fund manager invests at his/her own discretion but within the prescribed investment restrictions.

The fund's return depends primarily on interest rates, issuer creditworthiness and interest income. The return may also be affected by currency fluctuations where active or unhedged positions exist.

The fund's income is added annually to the fund's assets for reinvestment (reinvestment).

Intended retail investor

This investment fund is suitable for professional investors as well as private investors with no or limited investment experience who are able to bear potential investment losses. This investment fund aims to achieve its performance materially through a flow of regular income and meets the requirements for sustainable investments, and under normal market conditions grants daily access to the invested capital. It meets medium-term investment requirements.

What are the risks and what could I get in return?

Indicator

What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

Losses are not covered by any investor compensation or guarantee scheme. In addition, in relation to UBS Switzerland AG, which as the Fund's custodian is responsible for the safekeeping of its assets (the "Custodian"), there is a potential risk of default in the event that the Fund's assets held with the Custodian are lost. However, this risk of default is limited as the Custodian is required by law and regulation to segregate its own assets from the Fund's assets. The Custodian shall be liable to the Fund or the Fund's investors for any loss of a financial instrument held in custody by the Custodian or its delegate, unless the Custodian can demonstrate that the loss resulted from an external event beyond its control.

What are the costs?

Costs over time

The table shows the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods, we have assumed that the product performs as shown in the moderate scenario.
- 10 000 CHF is invested.
