What is this product?

Type

Multi Manager Access II is an undertaking for collective investment in transferable securities (UCITS) incorporated in the legal form of an investment company with variable capital (SICAV) under Part I of the Luxembourg 2010 Law on undertakings for collective investment.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

This actively managed sub-fund promotes environmental and/or social characteristics but does not have a sustainable investment objective.

The investment objective of the sub-fund is to seek long-term real returns by investing in target UCIs or via dedicated portfolios. A minimum of 90% of the sub-fund's assets (excluding investments in cash, cash equivalents and derivatives used for hedging and efficient portfolio management purposes) shall be invested in selected investment strategies which promote environmental and/or social characteristics, or selected investment strategies with sustainable investment or a reduction in carbon emissions as their objective.

All investment strategies are selected based on due diligence conducted by the Portfolio Manager, which includes an assessment of the ESG intentionality of the target UCI or Dedicated Portfolio. As a consequence, the ESG analysis coverage rate applied by the Portfolio Manager within the portfolio will be at least 90% of the net assets of the sub-fund, excluding investments in cash and cash equivalents held accessorially, debt securities issued by public sector (i.e. State owned) or quasi-public sector issuers and financial derivative instruments used for hedging and efficient portfolio management purposes. There are potential inconsistencies between the selected ESG strategies as these may be managed by different third party investment managers, who each may have different criteria, approaches, constraints, etc, when considering ESG criteria.

The sub-fund invests worldwide on a broadly diversified basis in fixed income and equity securities. The assets of the sub-fund are invested following the principle of risk diversification. The Portfolio Manager may also employ derivatives in achieving the investment objective of the sub-fund. The sub-fund is actively managed and is not constrained by a benchmark index.

The return of the fund depends primarily on the development of capital markets. To varying degrees, it will be a function of the following components: equity market development and dividend payments, development of interest rates, creditworthiness of the entities issuing the invested instruments and interest income. The return may also be affected by currency fluctuations, where active or unhedged positions exist. The income in respect of an accumulation share class is not distributed but is retained in the sub-fund.

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

What happens if UBS Asset Management (Europe) S.A. is unable to pay out?

What are the costs?
