### What is this product?

#### Type

The Sub-Fund is part of LO Funds (the "Fund"), a public liability company (société anonyme) incorporated under the laws of the Grand Duchy of Luxembourg as an investment company with variable share capital. The Fund is subject to part I of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment in transferable securities ("UCITS").

#### Term

The Sub-Fund has no maturity date. The PRIIP manufacturer is entitled to terminate the Sub-Fund unilaterally under the circumstances provided for in the constitutive documents of the Fund. A liquidation of the Fund will cause the automatic termination of the Sub-Fund.

#### Objectives

The Sub-Fund is actively managed. The Bloomberg Barclays Global Aggregate TR index is used for performance comparison as well as internal risk monitoring purposes, without implying any particular constraints to the Sub-Fund's investments. Securities targeted by the Sub-Fund can be similar to those of the index to an extent that varies overtime but their weighting is expected to materially differ. The performance of the Sub-Fund may deviate materially from that of the index. The objective of the Sub-Fund is to generate a regular income and capital appreciation by investing mainly in bonds whose use of proceeds are aimed at financing projects that have a positive impact on the environment. In selecting individual bonds, the Investment Manager will apply qualitative and quantitative criteria to assess the environmental impact of the use of proceeds as well as perform a fundamental analysis of issuers. This approach aims at optimizing resource allocation and maximizing environmental impact while ensuring strict financial selection of issues. The Investment Manager will use its discretion with regard to the selection of instruments, issuers, maturities and currencies. The use of derivatives is used for hedging and efficient of portfolio management but not as part of investment strategy.

This Sub-Fund may not be appropriate for investors who plan to withdraw their money within 3 years.

#### Sustainability

The Fund has been classified as a financial product subject to Article 9 of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial sector (the "SFDR"). The Fund will seek to invest in high quality companies that, due to the nature of business, serve as impact generators that tackle the climate transition opportunity. The Fund will aim to invest in companies with sustainable financial models, and with business models and practices showing resilience and ability to evolve and benefit from trends driven by the climate transition.

#### Benchmark

A proxy benchmark has been identified for performance comparison: Bloomberg Global Aggregate Hedged (JPY).

#### Intended retail investor

The Sub-Fund is intended for eligible investors who have sufficient experience or have obtained professional advice to assess the risk of investing, have a long-term investment horizon and have sufficient resources to be able to bear any losses (which may equal to the total amount invested) that may result from an investment in the Sub-Fund.

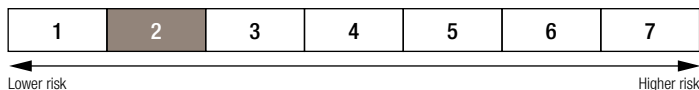

## What are the risks and what could I get in return?

### RISK AND REWARD PROFILE



**⚠** The summary risk indicator assumes you keep the product for 3 years. Be aware of currency risk. We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

## What happens if Lombard Odier Funds (Europe) S.A. is unable to pay out?

The Fund's ability to pay out would not be affected by the insolvency of the manufacturer. You may however face a financial loss should the depositary default on its obligations. Such default risk is limited as the depositary is required by law and regulation to segregate its own assets from the assets of the Fund. There is no compensation or guarantee scheme in place which may offset, all or any of, these potential losses.

## What are the costs?

### COSTS OVER TIME

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

(\*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 0.99% before costs and 0.29% after costs.
