### What is this product?

#### Type

The Sub-Fund is part of LO Funds (the "Fund"), a public liability company (société anonyme) incorporated under the laws of the Grand Duchy of Luxembourg as an investment company with variable share capital. The Fund is subject to part I of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment in transferable securities ("UCITS").

#### Term

The Sub-Fund has no maturity date. The PRIIP manufacturer is entitled to terminate the Sub-Fund unilaterally under the circumstances provided for in the constitutive documents of the Fund. A liquidation of the Fund will cause the automatic termination of the Sub-Fund.

#### Objectives

LO Funds - DataEdge Market Neutral is a diversified equity long/short, sector market neutral strategy leveraging on trading signal generation based on the latest breakthroughs in big data and predictive analytics to identify key business trend inflections.

The Investment Manager will implement its strategy by getting exposure to companies that it believes to be undervalued and by getting short exposure to companies that it believes to be overvalued. However, the aim of the Investment Manager is to remain market neutral by targeting, under feasibility constraints, a net zero dollar exposure at the global portfolio level, and sector level.

The strategy relies on the use, acquisition, and analysis of alternative data points across multiple geographies, sectors, and sources, such as but not limited to credit card transactions, digital receipts, web traffic, application activity or geolocation. These data have for objective to provide an information edge on companies, including but not limited to sales, revenues, new customers and engagement patterns that are key performance indicators (KPI) of a company influencing its share price.

From a geographic perspective, the investment universe is predominantly focused on the United States. With the amount of alternative data available projected to grow further over the future, the coverage universe, either in terms of number of stocks, regions or sectors, is expected to expand accordingly.

Risk management is performed at the portfolio level, while an independent team oversees investment and operational risks.

This Sub-Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities.

### PERFORMANCE SCENARIOS

The figures shown include all the costs of the product itself. The figures do not take into account your personal tax situation, which may also affect how much you get back. ### What happens if Lombard Odier Funds (Europe) S.A. is unable to pay out?

The Fund's ability to pay out would not be affected by the insolvency of the manufacturer. You may however face a financial loss should the Depositary default on its obligations.
