### What is this product?

#### Type

The Sub-Fund is part of LO Funds (the "Fund"), a public liability company (société anonyme) incorporated under the laws of the Grand Duchy of Luxembourg as an investment company with variable share capital. The Fund is subject to part I of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment in transferable securities ("UCITS").

#### Term

The Sub-Fund has no maturity date. The PRIIP manufacturer is entitled to terminate the Sub-Fund unilaterally under the circumstances provided for in the constitutive documents of the Fund. A liquidation of the Fund will cause the automatic termination of the Sub-Fund.

#### Objectives

The Sub-Fund is actively managed. The Sub-Fund is not managed in reference to a benchmark.

"DOM" refers to "Diversified Orthogonal Multi-strategy".

The Sub-Fund's objective is to generate returns by implementing a global macro strategy, aimed at harvesting a diversified set (multi-strategy) of orthogonal (uncorrelated) sources of returns.

To achieve this aim, the Investment Manager constructs a diversified portfolio, combining rule-based strategies and discretionary exposures, which aim to generate positive returns across cover different market regimes.

Strategies may include, (i) rule-based quantitative strategies aiming to harvest alternative sources of returns from exposure to specific risk premia as well as relative-value opportunities within specific asset classes; (ii) macro strategies seeking to capture macroeconomic trends and exploit mispricings arising from divergence between economic fundamentals and political and policy actions, thus generating asymmetric risk/return opportunities; (iii) strategies seeking to apply a value approach to purchasing and selling options; (iv) convex (i.e. defensive) strategies with asymmetric payoff profile seeking to protect the portfolio against tail risks; and (v) strategies which combine any of the previous approaches.

The investment process encapsulates three types of allocation: (i) a strategic allocation, leading to a diversified portfolio considering a full market cycle, (ii) a dynamic allocation, leading to a portfolio adapted to the current market and macro environment, (iii) an opportunistic allocation with a view to capitalize on unique investment opportunities.

The Sub-Fund may invest into a wide range of financial derivative instruments and OTC derivatives to take long and short positions on any asset classes, currencies (OECD currencies and/or Emerging Market currencies), markets (including Emerging Markets) and/or indices (including commodity indices).

This Sub-Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

#### Sustainability

This product is not a financial product subject to Article 8 or Article 9 of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial sector (the "SFDR"). The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities.

#### Intended retail investor

The Sub-Fund is only suitable for (i) Institutional Investors or retail investors who qualify as "Financially Sophisticated Investors", (ii) have a long-term investment horizon and (iii) have sufficient resources to be able to bear any losses (which may equal to the total amount invested) that may result from an investment in the Sub-Fund. A Financially Sophisticated Investor is an investor who (i) has knowledge of, and investment experience in, financial markets generally and financial products which invest in securities and/or derivatives with complex features and (ii) understands and can evaluate the strategy, characteristics and risks of the Sub-Fund in order to make an informed investment decision.

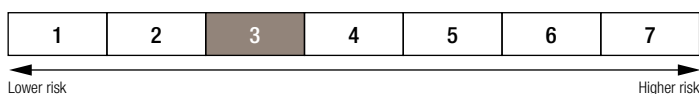

## What are the risks and what could I get in return?

### RISK AND REWARD PROFILE

## What happens if Lombard Odier Funds (Europe) S.A. is unable to pay out?

The Fund's ability to pay out would not be affected by the insolvency of the manufacturer. You may however face a financial loss should the depositary default on its obligations. Such default risk is limited as the depositary is required by law and regulation to segregate its own assets from the assets of the Fund. There is no compensation or guarantee scheme in place which may offset, all or any of, these potential losses.

## What are the costs?

### COSTS OVER TIME

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. (\*) This illustrates how costs reduce your return each year over the holding period.
