### What is this product?

#### Type

This product LO Funds (CH) is a Swiss umbrella fund in contractual form of the category "Other funds for traditional investments".

#### Term

The sub-fund has no maturity date. The fund management company is entitled to terminate the sub-fund unilaterally under the circumstances provided for in the constitutive documents of the Fund. A liquidation of the Fund will cause the automatic termination of the sub-fund.

#### Objectives

The sub-fund aims to replicate the performance of the LOIM Commodity Ex-Agri Index, which consists of commodities chosen from three main sectors - energy, natural gas and metals (precious and industrial). Agriculture is not permitted. Exposure to the above investments is mainly through one or more swap contracts, but on a secondary basis also through futures, certificates and structured products. The performance of the sub-fund may deviate from that of the index for reasons including the costs of structuring and replication. The fund manager applies a proprietary method to determine and adjust the weighting of each commodity (the "risk parity" method). This adjusts the weight of each commodity so they all make roughly the same contribution to overall portfolio risk. The higher the risk of fluctuation of a particular commodity, the lower its weighting in the portfolio.

This sub-fund may not be appropriate for investors who plan to withdraw their money within 5 years.

#### Benchmark

A proxy benchmark has been identified for performance comparison: Bloomberg Commodity ex-Agri & Livestock Total Return Index.

#### Intended retail investor

The sub-fund is intended to eligible investors who have sufficient experience or have obtained professional advice to assess the risk of investing, have a long-term investment horizon and have sufficient resources to be able to bear any losses (which may equal to the total amount invested) that may result from an investment in the sub-fund.

## What are the risks and what could I get in return?

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

## What happens if Lombard Odier Asset Management (Switzerland) SA is unable to pay out?

The Fund's ability to pay out would not be affected by the insolvency of the fund management company. You may however face a financial loss should the Depositary default on its obligations. Such default risk is limited as the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. There is no compensation or guarantee scheme in place which may offset, all or any of, these potential losses.

## What are the costs?

### COSTS OVER TIME

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. (\*) This illustrates how costs reduce your return each year over the holding period. Part of the costs can be paid to the distributor who distributes the product for the services they provide. They will inform you of the amount.
