### What is this product?

#### Type

The Sub-Fund is part of PriviEdge (the "Fund"), a public liability company (société anonyme) incorporated under the laws of the Grand Duchy of Luxembourg as an investment company with variable share capital. The Fund is subject to part I of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment in transferable securities ("UCITS").

#### Term

The Sub-Fund has no maturity date. The PRIIP manufacturer is entitled to terminate the Sub-Fund unilaterally under the circumstances provided for in the constitutive documents of the Fund. A liquidation of the Fund will cause the automatic termination of the Sub-Fund.

#### Objectives

The Sub-Fund is actively managed. The Sub-Fund is not managed in reference to a benchmark. The Sub-Fund investment objective is to seek attractive long-term returns through an investment portfolio comprised of long and short positions in equity securities. The Sub-Fund invests in equity and equity related securities issued by companies worldwide (including Emerging Markets), as well as in Cash and Cash Equivalents. The Investment Manager will invest at least 60% of the Sub-Fund's long and short equity positions (in aggregate) in companies that have their registered office in the United Kingdom or that do not have their registered office in the United Kingdom but either (i) carry out a predominant proportion of their business activity in the United Kingdom, or (ii) are holding companies which predominantly own companies with registered offices in the United Kingdom, or (iii) are listed on the London Stock Exchange. The Investment Manager may use a wide range of financial derivative instruments, such as options, futures (including, but not limited to, equity indices and currencies), CFD and swaps in order to increase or reduce its exposure to specific markets, sectors, issuers, commodities and currencies. In certain circumstances, the net exposure of the Sub-Fund to financial markets may be negative. In particular, long equity positions may be held through a combination of direct investment and/or derivative instruments, and short positions will be held through derivative positions. The Sub-Fund may invest up to 10% of its net assets in UCIs.

This Sub-Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

#### Sustainability

This product is not a financial product subject to Article 8 or Article 9 of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial sector (the "SFDR"). The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities.

## What are the risks and what could I get in return?

### RISK AND REWARD PROFILE



**⚠** The summary risk indicator assumes you keep the product for 5 years. Be aware of currency risk. We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

The following risks may be materially relevant but may not always be adequately captured by the summary risk indicator and may cause additional loss: Operational risk and risks related to asset safekeeping, Concentration risk and Financial, economic, regulatory and political risks.

### PERFORMANCE SCENARIOS

## What happens if Lombard Odier Funds (Europe) S.A. is unable to pay out?

The Fund's ability to pay out would not be affected by the insolvency of the manufacturer. You may however face a financial loss should the Depositary default on its obligations. Such default risk is limited as the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. There is no compensation or guarantee scheme in place which may offset, all or any of, these potential losses.

## What are the costs?

### COSTS OVER TIME

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

(\*) This illustrates how costs reduce your return each year over the holding period.
