What is this product?

Mirabaud (the "Umbrella Fund"), with multiple compartments ("société d'investissement à capital variable" ("SICAV") à compartiments multiples) is established and governed in accordance with the provisions of by Part I of the Luxembourg law of 17th December 2010 and thus qualifies as a UCITS

Term

The term of the Sub-Fund is unlimited and therefore there is no maturity date. The Management Company may not unilaterally terminate the Sub-Fund.

Objectives

Investment Objective

The objective of the Sub-Fund is to achieve long-term capital growth by investing primarily in a diversified portfolio of convertible securities, globally. The Sub-Fund will invest, primarily its assets in bonds, convertible into equities of companies as well as in synthetic convertible transferable securities of issuers having their registered office or carrying out the majority of their business in the United States, Europe and Asia, including emerging markets. The Sub-Fund's exposure to currencies other than its reference currency may be hedged against the reference currency.

Investment Policy


The Sub-Fund is actively managed. The Benchmark of the Class is Refinitiv Global Focus CB hedged GBP and is only used for comparison purposes and as part of the computation of the performance fees.

Extra financial considerations (Environmental, Social and Governance ("ESG")) are fully integrated in the investment process of the Sub-Fund. Therefore, the Sub-Fund will focus on companies whose social and environmental factors and methods of governance have a sustainable impact on financial performance. All of the three ESG criteria are applied according to the following main criteria:

• Governance: Board structure, independence and diversity; business ethics, bribery and corruption.

What are the risks and what could I get in return?

Summary Risk Indicator (SRI)

What happens if Mirabaud Asset Management (Europe) SA is unable to pay out?

You may not face a financial loss due to the default of Mirabaud Asset Management (Europe) SA. The assets of the Fund are held in safekeeping by its depositary, Bank Pictet & Cie (Europe) AG – Luxembourg branch. In the event of the insolvency of Mirabaud Asset Management (Europe) SA, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. This risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. Costs over Time
