What is this product?

Term

The term of the Sub-Fund is unlimited and therefore there is no maturity date. The Management Company may not unilaterally terminate the Sub-Fund.

Objectives

Investment Objective

The objective of the Sub-Fund is to achieve capital growth in the medium to long-term by investing primarily, directly or indirectly in equities and equity-type transferable securities of small and medium-sized companies having their registered office in Europe ex-UK, or carrying the majority of their activities in Europe ex-UK or generating the majority of their revenue from Europe ex-UK or listed on a European ex-UK regulated market. These companies may include European emerging companies and Russian companies.

Investment Policy


The Sub-Fund is eligible to the PEA (French Equity Savings Plan).

The Sub-Fund is actively managed. The Benchmark of the Class is MSCI Europe ex UK Small TR Net GBP and is shown for comparison purposes only, without implying any particular constraints to the Sub-Fund's investments.

Extra financial considerations (Environmental, Social and Governance ("ESG")) are fully integrated in the investment process of the Sub-Fund. Therefore, the Sub-Fund will focus on companies whose social and environmental factors and methods of governance have a sustainable

Summary Risk Indicator (SRI)

What happens if Mirabaud Asset Management (Europe) SA is unable to pay out?

In the event of the insolvency of Mirabaud Asset Management (Europe) SA, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss.
