What is this product?

Type The Company is an open-ended umbrella investment company with variable capital (société d'investissement à capital variable) incorporated under the form of a société anonyme in Luxembourg on 21 March 2000, under the name "BSI-MULTINVEST". It qualifies as an undertaking for collective investment in transferable securities ("UCITS") under Part I of the 2010 Law

Objectives

Product objectives The investment objective of the Sub-Fund is to deliver a consistent risk-adjusted return in all market environments over rolling 12 month periods

Investment approach The Fund will gain exposure to a diverse global allocation of asset classes and may invest directly or indirectly in sovereign and corporate bonds, equities and commodities, infrastructure and property. Indirect exposure to these asset classes will, where applicable, be generated through investing in collective investment schemes, including exchange-traded funds (index-tracking funds that can be traded on exchanges just like a stock). Where the Fund invests in other collective investment schemes, underlying managers are selected first based on macros a price occomplish. underlying managers are selected first based on macro or micro economic views and then filtered based on data analysis using proprietary tools and supplemented by interviews with key decision makers and operating and liquidity risk scoring. No direct investment shall be made in commodities, liquidity risk scoring. No direct investment shall be made in commodities, infrastructure or property. The Fund is permitted to invest less than 10% of its NAV in China A shares which are listed on the Shanghai Stock Exchange using the Shanghai-Hong Kong Stock Connect or the Shenzhen Stock Exchange using the Shenzhen-Hong Kong Stock Connect. The sovereign and corporate bonds in which the Fund may invest may have fixed or floating rates of interest. No credit rating requirements will apply to these instruments and the Fund may generate exposure of more than 30% of net assets in bonds which constitute below investment grade securities. There will be no restrictions on the investment type, geographical or economic sector to which the Fund is exposed. However, any exposure to emerging markets will which the Fund is exposed. However, any exposure to emerging markets will not exceed 30% of the Fund's net assets and up to 10% of net assets may be exposed to Russia. The Sub-Fund may also invest in contingent convertible

Benchmark The Fund's benchmark is BofA Merrill Lynch USD 1M Deposit Offered Rate Constant Maturity Index + 3% and may be used for comparative purposes only. The Fund is actively managed and as such does not seek to replicate its benchmark index, but instead may differ from the performance benchmark in order to achieve its objective. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities.

Performance Scenarios

Redemption policy Shares in the Fund can be bought and sold daily (every Business Day of the Fund). Shares will be redeemed at the nav per share calculated on the relevant valuation day, with applications needing to be received by 12:00 pm (Luxembourg time) on the preceding business day to be processed at that day's NAV. There is no redemption charge.

Distribution policy Any income arising from this Share Class will be accumulated and automatically reinvested.

Exchange policy Subject to the conditions set down in the Prospectus, you are entitled to switch from one share class to another, either in the Fund or in another sub-fund of the Company. Please refer to the Prospectus for further information to the Company. information on how to switch.

Asset segregation The Fund is a sub-fund of the Company, an umbrella fund with segregated liability between sub-funds. You can find out more information about the umbrella fund in the Prospectus.

Such instruments may include forward foreign exchange contracts index options and convertible securities. Intended retail investor This Fund is suitable for investors seeking a low to medium risk profile and a medium to long term investment (i.e. at least 3 to 5 $\,$ years).

Term The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. Waystone Management Company (Lux) S.A. is not entitled to terminate the product unilaterally. The Company may mandatorily redeem any shares that are owned or held by someone in violation of laws or regulations, or if holding those shares could result in negative tax or financial consequences for the Company, such as requiring registration under various securities or investment

What happens if Waystone Management Company (Lux) S.A. is unable to pay out?
The Management Company of the Fund has no obligation to pay out since the Fund design does not contemplate any such payment being made. You are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should the Fund default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.
