#### What is this product?

The Fund was incorporated as a société anonyme, an open-ended fund formed under the amended law of 17 December 2010 on undertakings for collective investment. It is an umbrella fund with multiple compartments, the Sub-Fund being one of these compartments. The Shares are

This actively managed Sub-Fund aims to achieve attractive investment returns by investing in Green Bonds. It has a sustainable investment objective within the meaning of Article 9 SFDR, which consists in investing in debt instruments issued for projects and/or by issuers that contribute to pre-defined so called "Impact Pillars", with an environmental focus. More details can be found in the prospectus.

While respecting the principle of risk diversification, the Sub-Fund invests worldwide at least 80% of its net assets in various debt instruments classified as "Green Bonds" according to international standards such as the Green Bond Principles of the International Capital Market Association (ICMA), including asset-backed and mortgage-backed securities ("ABS/MBS"), convertible and warrant bonds issued by public and/or private borrowers worldwide, including emerging markets. The investments shall be made in a broad range of rating categories,

including the high yield sector.

Type of approach: The Sub-Fund mainly invests in the above mentioned Green Bonds contributing to its environmental Impact Pillars, i.e. clean and renewable energy, energy efficiency, resource efficiency, low-carbon transportation, agriculture and forestry as well as climate resilient infrastructure. Through these investments, the Sub-Fund partially intends to invest in sustainable investments with an environmental objective as defined by the EU Taxonomy. These objectives are: "climate change mitigation", "climate change adaptation", "sustainable use and protection of water and marine resources", "transition to a circular economy", "pollution prevention and control", "protection and restoration of biodiversity and ecosystems". Threshold: 100% of the securities in the Sub-Fund have the sustainability selection criteria applied to it. All investments qualifying as sustainable investments are screened against all adverse impact indicators relevant to the economic sector. Main methodological limits: potential inconsistency, inaccuracy or lack of availability of ESG data issued by third party providers.

Up to 20% of the Sub-Fund's net assets may be invested outside the aforementioned Green Bond universe. In total it may invest up to 10% in asset-backed and mortgage-backed securities ("ABS/MBS"), 15% in high yield securities, 20% in convertible and warrant bonds issued by public and/or private borrowers and 20% in money market instruments and bank deposits. It may also hold up to 20% of its net assets in bank deposits at sight.

The Sub-Fund may use derivatives to achieve the investment objective and for hedging purposes.

Redemption of shares: daily when banks in Luxembourg are open for normal business (see prospectus for details and exceptions).

Any income generated will be reinvested and included in the value of your Shares.

The Sub-Fund is not managed with reference to a benchmark. The portfolio manager has full investment discretion within the predefined

Taking into consideration the minimum recommended holding period, the return will depend on the performance of the underlying investments. The Fund's depositary is State Street Bank International GmbH, Luxembourg Branch.



The Shares do not have a maturity date. The Product Manufacturer can terminate the Shares unilaterally. The Shares, the Sub-Fund and the Fund can be terminated early and liquidated in the cases set out in the prospectus and the articles of incorporation of the Fund.

## What are the risks and what could I get in return?

The summary risk indicator (the "SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.



The risk indicator assumes you keep the product for 3 years. We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a mediumlow level, and poor market conditions are unlikely to impact our capacity to pay you.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the SRI.

#### What happens if Vontobel Asset Management S.A. is unable to pay out?

The investor may not face a financial loss due to the default of the Product Manufacturer.

The assets of the Fund are held in safekeeping by its depositary, State Street Bank International GmbH, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the Product Manufacturer, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. This risk is mitigated to a certain extent by the fact that the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations as set out in the agreement with the Depositary).

#### Cost over time

### How long should I hold it and can I take money out early?

Recommended holding period: 3 years

Based on the investment policy and the risk profile of the Sub-Fund, a holding period of 3 years is recommended. Investors can sell the investment at any time, irrespective of the recommended holding period, without additional cost. Shares can be sold daily (on business days). Exit costs are presented above.
