What is this product?

The Fund was incorporated as a société anonyme, an open-ended fund formed under the amended law of 17 December 2010 on undertakings for collective investment. It is an umbrella fund with multiple compartments, the Sub-Fund being one of these compartments. The Shares are a

This actively managed Sub-Fund aims to achieve the best-possible investment return by investing in global investment grade corporate debt securities. It is categorized as Article 8 SFDR. More details can be found in the prospectus.

The Sub-Fund invests at least two thirds of its assets in the fixed-income asset class by purchasing bonds and other fixed-interest and floating-rate securities denominated in freely convertible currencies, including preferred structures and securities with embedded derivatives, such as convertible bonds, contingent convertible bonds (so-called "CoCo Bonds"), asset-backed securities and mortgage-backed securities ("ABS/MBS"), as well as bonds with warrants, issued by public or private borrowers worldwide which have a Standard & Poor's rating of between A+ and BBB- or an equivalent rating from another recognized rating agency.

Bond investments below BBB- shall be limited in aggregate to maximum 20% of the Sub-Fund's net assets. Additionally, such investments are to be restricted to securities rated from a Standard & Poor's BB+ to BB- at the time of investment. In case investments suffer downgrades below that BB- limit, existing investments can be kept on a passive basis only and be limited to maximum 2% of the Sub-Fund's net assets.

Up to 33% of the Sub-Fund's net assets may be invested in money-market instruments and bank deposits for liquidity management and equities. Equity investments are only allowed on a passive basis, as a result of a conversion event for CoCo Bonds. In total it may invest up to 10% in asset-backed and mortgage-backed securities and 10% in contingent convertible bonds (CoCo-Bonds). It may also invest up to 33% in bank deposits and money market instruments for liquidity management. The Sub-Fund may also hold up to 20% of its nets assets in bank deposits at sight.

The Sub-Fund may use derivatives to achieve the investment objective and for hedging purposes.

Other information: The Sub-Fund invests in securities of corporate issuers that, in respect to the performed climate change related indicators (i.e. greenhouse gas intensity, carbon reduction path, exposure to fossil fuel), (i) perform well, or (ii) are on their way to perform well in these indicators, or (iii) where potential for improvement has been identified, based on the Investment Manager's analysis. The Sub-Fund will have a higher ESG score (the UN Global Compact profile) than the investment universe (i.e. global investment grade corporate debt market). It excludes securities of issuers applying certain conditions as disclosed in the sustainability-related information on the Sub-Fund's website http://am.vontobel.com/view/GCBMY#documents.

Redemption of shares: daily when banks in Luxembourg are open for normal business (see prospectus for details and exceptions). Any income generated will be reinvested and included in the value of your Shares.

The Sub-Fund is not managed with reference to a benchmark. The portfolio manager has full investment discretion within the predefined investment limits.

HN (hedged) shares are reserved for specific investors and do not grant any rebate or retrocessions. See prospectus for details. Taking into consideration the minimum recommended holding period, the return will depend on the performance of the underlying investments. The Fund's depositary is State Street Bank International GmbH, Luxembourg Branch.

This Sub-Fund is part of an umbrella fund. The various sub-funds are not liable for one another, i.e. only the gains and losses of this Sub-Fund are relevant for you as an investor. You can request the conversion of some or all of your Shares in the Sub-Fund in accordance with the "Conversion of Shares" section, unless stipulated otherwise in the special part of the sales prospectus.



The Shares do not have a maturity date. The Product Manufacturer can terminate the Shares unilaterally. The Shares, the Sub-Fund and the Fund can be terminated early and liquidated in the cases set out in the prospectus and the articles of incorporation of the Fund.

What are the risks and what could I get in return?

The summary risk indicator (the "SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.



The risk indicator assumes you keep the product for 5 years. We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a mediumlow level, and poor market conditions are unlikely to impact our capacity to pay you.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the SRI.

Other risks not captured in the SRI: liquidity, operational, legal or sustainability risks. Further details in the prospectus.

What happens if Vontobel Asset Management S.A. is unable to pay out?

The investor may not face a financial loss due to the default of the Product Manufacturer.

The assets of the Fund are held in safekeeping by its depositary, State Street Bank International GmbH, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the Product Manufacturer, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. This risk is mitigated to a certain extent by the fact that the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations as set out in the agreement with the Depositary).

What are the costs?

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

Based on the investment policy and the risk profile of the Sub-Fund, a holding period of 5 years is recommended. Investors can sell the investment at any time, irrespective of the recommended holding period, without additional cost. Shares can be sold daily (on business days). Exit costs are presented above.
