What is this product?

The fund is a contractual umbrella fund under Swiss law of the type "Other funds for traditional investments" pursuant to the Swiss Federal Act on Collective Investment Schemes (CISA) of June 23, 2006 with several subfunds.

Objective

The subfund's investment policy is to achieve an income.

The subfund mostly invests directly and indirectly in debt securities and book-entry debt securities denominated in Swiss francs.

The subfund invests in debt securities and book-entry debt securities denominated in Swiss france that are issued by companies domiciled either in Switzerland or abroad or guaranteed by the same and which take the sustainability criteria into account.

Derivatives can be used for hedging purposes and for efficient portfolio management. This does not produce a leverage effect.

Shares in the subfund can be redeemed on any working day, with the exception of public holidays in Switzerland or when a significant part of the stock exchanges and markets of the subfund is closed.

Income can be distributed each year.

Taking into consideration the minimum recommended holding period, the return will depend on the performance of the underlying investments. The custodian bank of the fund is State Street Bank International GmbH, Munich, Zurich Branch.
