The fund management company Vontobel Fonds Services AG is authorized in Switzerland and is supervised by FINMA. Vontobel Fonds Services AG is part of the Vontobel Group.

#### What is this product?

#### Type

The fund is a contractual umbrella fund under Swiss law of the type "Other funds for traditional investments" pursuant to the Swiss Federal Act on Collective Investment Schemes (CISA) of June 23, 2006 with several subfunds.

#### Objective

The subfund's investment policy is to generate a steady income supplemented by capital gains, while preserving the real value of the assets with additional income potential. The subfund adheres to the investment restrictions for pension funds in accordance with the Ordinance on Occupational Retirement, Survivors' and Disability Pension Plans (BVV2).

The subfund invests at least 40% in interest-bearing debt securities and book-entry debt securities and a maximum of 50% in equities and equity-like securities. Investments can be made by means of collective investment schemes (target funds).

The subfund mainly invests worldwide in securities of public and/or private-sector borrowers and in equity securities of companies which take the sustainability criteria into account.

Derivatives can be used for hedging purposes and for efficient portfolio management. This does not produce a leverage effect.

Shares in the subfund can be redeemed on any working day, with the exception of public holidays in Switzerland or when a significant part of the stock exchanges and markets of the subfund is closed.

Income is not paid out but is retained to be reinvested.

NV shares are exclusively reserved for certain investors within the meaning of the sales prospectus.

Taking into consideration the minimum recommended holding period, the return will depend on the performance of the underlying investments. The custodian bank of the fund is State Street Bank International GmbH, Munich, Zurich Branch.

#### Intended Retail Investor

The sub-fund is intended for retail investors with knowledge and/or experience of these types of products, that have long-term investment horizon and that have the ability to bear losses up to the amount they have invested in the sub-fund.

#### Term

This product has no expiration date. The subfund was established for an indefinite period of time. The fund management company is unilaterally entitled to liquidate the product at any time. The amount received by the investor in the event of early termination may be less than the amount invested.

## What are the risks and what could I get in return?

The summary risk indicator (the "SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.



The risk indicator assumes you keep the product for 6 years. We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a mediumlow level, and poor market conditions are unlikely to impact our capacity to pay you.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the SRI.

Other risks not captured in the SRI: liquidity, operational, legal or sustainability risks. Further details in the prospectus.

#### **Performance Scenarios**

#### What happens if Vontobel Fonds Services AG is unable to pay out?

The investor may not face a financial loss due to the default of the Product Manufacturer.

The assets of the Fund are held in safekeeping by its Custodian Bank, State Street Bank International GmbH, Munich, Zurich Branch (the "Custodian"). In the event of the insolvency of the Product Manufacturer, the Fund's assets in the safekeeping of the Custodian will not be affected. However, in the event of the Custodian's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. This risk is mitigated to a certain extent by the fact that the Custodian is required by law and regulation to segregate its own assets from the assets of the Fund. The Custodian will also be liable to the Fund for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations as set out in the agreement with the Custodian). Losses are not covered by an investor compensation or quaranteed scheme.

#### What are the costs?

#### Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. - In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

Recommended holding period: 6 years

Due to the investment policy and the risk profile of the subfund, a holding period of 6 years is recommended. Investors can sell the investment at any time at no additional cost regardless of the recommended holding period. Units may be sold on a daily basis (on bank working days). The exit costs are shown above.
