## What is this product?

### Туре

The fund is a contractual umbrella fund under Swiss law of the type "Other funds for traditional investments" pursuant to the Swiss Federal Act on Collective Investment Schemes (CISA) of June 23, 2006 with several subfunds.

# Objective

The subfund's investment policy is to generate a steady income supplemented by capital gains, while preserving the real value of the assets with additional income potential. The subfund adheres to the investment restrictions for pension funds in accordance with the Ordinance on Occupational Retirement, Survivors' and Disability Pension Plans (BVV2).

The subfund invests at least 40% in interest-bearing debt securities and book-entry debt securities and a maximum of 50% in equities and equity-like securities. Investments can be made by means of collective investment schemes (target funds).

The subfund mainly invests worldwide in securities of public and/or private-sector borrowers and in equity securities of companies which take the sustainability criteria into account.

Derivatives can be used for hedging purposes and for efficient portfolio management. This does not produce a leverage effect. Shares in the subfund can be redeemed on any working day, with the exception of public holidays in Switzerland or when a significant part of the stock exchanges and markets of the subfund is closed.

Income can be distributed each year.

R shares are reserved for investors who are in an employment relationship with a company of the Vontobel Group.

Taking into consideration the minimum recommended holding period, the return will depend on the performance of the underlying investments. The custodian bank of the fund is State Street Bank International GmbH, Munich, Zurich Branch.

### Intended Retail Investor

The sub-fund is intended for retail investors with knowledge and/or experience of these types of products, that have long-term investment horizon and that have the ability to bear losses up to the amount they have invested in the sub-fund.

#### Term

This product has no expiration date. The subfund was established for an indefinite period of time. The fund management company is unilaterally entitled to liquidate the product at any time. The amount received by the investor in the event of early termination may be less than the amount invested.

## What are the risks and what could I get in return?

The summary risk indicator (the "SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.



The risk indicator assumes you keep the product for 6 years. We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a mediumlow level, and poor market conditions are unlikely to impact our capacity to pay you.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the SRI.

# What happens if Vontobel Fonds Services AG is unable to pay out?

The investor may not face a financial loss due to the default of the Product Manufacturer.

The assets of the Fund are held in safekeeping by its Custodian Bank, State Street Bank International GmbH, Munich, Zurich Branch (the "Custodian"). In the event of the insolvency of the Product Manufacturer, the Fund's assets in the safekeeping of the Custodian will not be affected. However, in the event of the Custodian's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss.
