What is this product?

The Fund was incorporated as a société anonyme, an open-ended fund formed under the amended law of 17 December 2010 on undertakings for collective investment. It is an umbrella fund with multiple compartments, the Sub-Fund being one of these compartments. The Shares are a

This actively managed Sub-Fund aims to achieve long-term capital growth in EUR and has a sustainable investment objective within the meaning of Article 9 SFDR, which consists of investing in issuers that contribute to pre-defined so called "Impact Pillars" through their products and services. More details can be found in the prospectus.

At least 80% of the sub-fund's assets are exposed to the equity markets by investing its assets in equities, equity-like transferable securities, including depository receipts, such as ADRs and GDRs, and including real estate equities and REITs, etc., issued by companies worldwide whose economic activities contribute to an environmental objective and/or a social objective in the investment manager's opinion ('impact'). It may invest via Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect in China A-Shares.

Type of approach: The Sub-Fund mainly invests in securities issued by companies worldwide whose products or services contribute to an environmentally sustainable objective in the investment manager's opinion. It focuses on eight core impact pillars ('Impact Pillars'): clean water, clean energy, sustainable cities, innovative industry & technology, good health & well-being, sustainable food & agriculture, responsible consumption and equal opportunities. The targeted companies provide products and services along the whole value chain, which have the potential to tackle today's pressing problems such as population growth, urbanization and rising inequalities. The implementation of positive impact selection criteria and ESG assessment lead to the exclusion of at least 20% of potential investments. Investment universe: global listed equity markets. 100% of the securities in the Sub-Fund have the ESG and impact selection criteria applied to it. Main methodological limits: potential inconsistencies, inaccuracy or lack of availability of ESG data issued by external third party providers.

It may also hold up to 20% of its net assets in bank deposits at sight.

The Sub-Fund may use derivatives for hedging purposes.

The currency of this class is NOT hedged against the Sub-Fund's main currency. The investor consequently bears the full currency risk. Redemption of shares: daily when banks in Luxembourg are open for normal business (see prospectus for details and exceptions). Any income generated will be reinvested and included in the value of your Shares.

The Sub-Fund is not managed with reference to a benchmark. The portfolio manager has full investment discretion within the predefined investment limits.

N shares are reserved for specific investors and do not grant any rebate or retrocessions. See prospectus for details.

Taking into consideration the minimum recommended holding period, the return will depend on the performance of the underlying investments. The Fund's depositary is CACEIS Bank, Luxembourg Branch.

This Sub-Fund is part of an umbrella fund. The various Sub-Funds are not liable for one another, i.e. only the gains and losses of this Sub-Fund are relevant for you as an investor. You can request the conversion of some or all of your Shares in the Sub-Fund in accordance with the "Conversion of Shares" section of the prospectus.


The Sub-Fund is intended for retail investors with knowledge and/or experience of these types of products, that have obtained appropriate investment advice, that have long-term investment horizon and that have the ability to bear losses up to the amount they have invested in the Sub-Fund.

Term

The Shares do not have a maturity date. The Product Manufacturer can terminate the Shares unilaterally. The Shares, the Sub-Fund and the Fund can be terminated early and liquidated in the cases set out in the prospectus and the articles of incorporation of the Fund.

What are the risks and what could I get in return?

The summary risk indicator (the "SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.



The risk indicator assumes you keep the product for 6 years. We have classified this product as 4 out of 7, which is a medium risk class

This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the SRI.

What happens if Vontobel Asset Management S.A. is unable to pay out?

The investor may not face a financial loss due to the default of the Product Manufacturer.

The assets of the Fund are held in safekeeping by its depositary, CACEIS Bank, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the Product Manufacturer, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. This risk is mitigated to a certain extent by the fact that the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations as set out in the agreement with the Depositary).

Cost over time

How long should I hold it and can I take money out early?

Recommended holding period: 6 years

Based on the investment policy and the risk profile of the Sub-Fund, a holding period of 6 years is recommended. Investors can sell the investment at any time, irrespective of the recommended holding period, without additional cost. Shares can be sold daily (on business days). Exit costs are presented above.
