What is this product?

Type

The Fund was incorporated as a société anonyme, an open-ended fund formed under the amended law of 17 December 2010 on undertakings for collective investment. It is an umbrella fund with multiple compartments, the Sub-Fund being one of these compartments. The Shares are a class of shares in the Sub-Fund.

Objective

This actively managed Sub-Fund aims to achieve good investment returns in USD over a fixed period, by investing primarily in emerging market debt securities.

It may invest up to 100% of its net assets in interest-bearing securities in a broad range of rating categories, including up to 30% in high yield and up to 30% in non-rated securities. Up to 25% may be invested in convertible bonds and warrant bonds and 20% in asset-backed and mortgage-backed securities. It may not invest actively into distressed securities but only hold them to a maximum of 5% in case holdings are downgraded and become distressed. It mainly invests in securities denominated in hard currencies (as defined in the prospectus) issued or guaranteed by corporate or government, government-related and supra-national issuers domiciled in, having their business activities in or exposed to emerging markets. It may invest indirectly in the above instruments via UCITS and/or other UCIs.

Up to one third of the Sub-Fund's assets may be invested in asset classes and financial instruments outside the aforementioned investment universe, in particular in fixed-income securities and money market instruments issued or guaranteed by corporate or government, government-related and supra-national issuers domiciled in, having their business activity in or exposed to developed markets, money market instruments and bank deposits for liquidity management and in equities (only as a result of a conversion event). It may also hold up to 20% of its net assets in bank deposits at sight. During the 3 months prior to Maturity, it may hold up to 100% in money market instruments (such as US Treasury Bills), bank deposits and hold bank deposits at sight.

The Sub-Fund may use derivatives to achieve the investment objective and for hedging purposes. Currency, credit and interest rate risks may be actively managed through the use of derivative financial instruments.

There will be an initial subscription period prior to Sub-Fund's launch, starting on 02 April 2024 and ending on 14 May 2024. After this period, the Board of Directors may close the Sub-Fund for further subscriptions. The board of directors may also decide, at its discretion, not to launch the Sub-Fund if the subscriptions level is not sufficient to adequately deploy its investment strategy. It has a limited duration and will be terminated on 14 May 2027 (the "Maturity").

Redemption of Shares: daily when banks in Luxembourg are open for normal business (see prospectus for details and exceptions). This Sub-Fund may not be suitable for investors who want to withdraw their money before Maturity.

Income may be paid out each year and is paid out of gross investment income. Charges are paid from invested capital which will either be eroded or future growth constrained.

The Sub-Fund is not managed with reference to a benchmark. The portfolio manager has full investment discretion within the predefined investment limits.

AHI (hedged) Gross Shares are exclusively reserved for institutional investors.

Taking into consideration the minimum recommended holding period, the return will depend on the performance of the underlying investments.

The Fund's depository is CACEIS Bank, Luxembourg Branch.

This Sub-Fund is part of an umbrella fund. The various Sub-Funds are not liable for one another, i.e. only the gains and losses of this Sub-Fund are relevant for you as an investor. You can request the conversion of some or all of your Shares in the Sub-Fund in accordance with the "Conversion of Shares" section of the prospectus.

Intended Retail Investor

The Sub-Fund is intended for retail investors with knowledge and/or experience of these types of products, who have obtained appropriate investment advice, who have short to medium-term investment horizon and have the ability to bear losses up to the amount they have invested in the Sub-Fund.

Term

The maturity date of the product is 14 May 2027. The Product Manufacturer can terminate the Shares unilaterally. The Shares, the Sub-Fund and the Fund can be terminated early and liquidated in the cases set out in the prospectus and the articles of incorporation of the Fund.

What are the risks and what could I get in return?

The summary risk indicator (the “SRI”) is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the SRI.

Other risks not captured in the SRI: liquidity, operational, legal or sustainability risks. Further details in the prospectus.

This product does not include any protection from future market performance so you could lose some or all of your investment.

The Shares have a limited duration and are designed to be terminated on 14 May 2027.

The risk indicator assumes you keep the product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

What happens if Vontobel Asset Management S.A. is unable to pay out?

The investor may not face a financial loss due to the default of the Product Manufacturer.

The assets of the Fund are held in safekeeping by its depositary, CACEIS Bank, Luxembourg Branch (the “Depositary”). In the event of the insolvency of the Product Manufacturer, the Fund’s assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary’s insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. This risk is mitigated to a certain extent by the fact that the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations as set out in the agreement with the Depositary).

What are the costs?

Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: until 14/05/2027

It is recommended to hold the Product until its maturity date. Investors can sell the Product before its maturity without additional cost. Shares can be sold daily (on business days). Exit costs are presented above.
