### **Investment Objective**

The investment objective of JSS Sustainable Equity – Next-Gen Consumer (the "Sub-Fund") is primarily to achieve capital appreciation through global equity investments.

### Investment Policy

The assets of the the Sub-Fund are mainly invested worldwide either directly (min. 67%) or indirectly in equity securities of companies whose products and services are driven by "Next-Generation" consumers. "Next-Generation" consumers are defined as those born after 1980 i.e. generations "Y", "Z" and "alpha". the Sub-Fund will focus mainly on 4 defined next generation consumption themes: "Responsible Living" - the emphasis on sustainable and conscious consumption; "Experience First" - the desire for active & out-of-home-driven consumption; "Premium Offering" – the aspiration for personalisation, innovation & quality; and "Seamless & Connected" – the transfer of consumption online. Next generations allocate a higher proportion of their spending to the above described themes when compared to older generations. The Sub-Fund invests in companies that benefit from these next
