Investment Objective

The investment objective of JSS Equity – All China (the "Sub-Fund") is to achieve long-term capital growth by investing in companies in China and other investments permitted under the investment policy.

Investment Policy

The Sub-Fund mainly invests either directly (min. 67% of the Sub-Funds assets) or indirectly in all forms of equity securities (such as ordinary and preference shares, depositary receipts, etc.) domiciled in People's Republic of China ("PRC"), or whose business activities are concentrated in the PRC or, in the case of holding companies, that are invested mainly in shares of companies domiciled in the PRC. These investments may be listed within the PRC (onshore) or outside of the PRC (offshore). The Sub-Fund will invest into Chinese A shares (onshore) that are traded via Stock Connect. Chinese A shares are renminbi-denominated shares of
