# What is this product?

#### Type

A contractual investment fund of the "other funds for traditional investments" type.

#### **Term**

The investment fund is established for an indefinite period. The Fund Management Company may initiate the dissolution of the investment fund by terminating the fund agreement.

#### **Objectives**

#### **Investment Objective**

The Fund seeks to achieve long-term capital growth.

#### **Investment Policy**

Investments are mainly made in contracts regarding various commodities scheduled for a future date (futures). Commodity investments are generally selected with the aim of achieving optimum risk distribution and therefore reducing risk. The following measures are designed to optimise risk distribution: 1. equal consideration of the different commodity sectors (energy, agricultural commodities and metals incl. gold), 2. equal weighting of individual commodities within a sector, 3. improvement of the risk distribution by selecting commodities that are produced as independently as possible.

## **Share Class Policy:**

This unit class of the Fund distributes income to investors in December as a general rule.

The reference currency of this unit class is CHF. The currency risk of investments not denominated in CHF is largely hedged against the CHF.

#### Processing of subscription and redemption orders

You can buy and sell units in this Fund on any bank business day in Switzerland.

#### Intended retail Investor

The Fund is suited to investors with a long-term investment horizon seeking capital growth. It is intended as a supplementary investment in the commodities sector for all categories of investor. Thanks to its diversified investment strategy, the Fund may contribute to risk reduction as a supplementary investment in a mixed portfolio and is suitable as a core investment in the alternative asset class of commodities. Commodities are subject to higher price risk than equities. Investors can exploit any resulting fluctuations in the net asset value of the fund units and are not tied to a specific date on which to realise the investment.

# **Risk Indicator**
