## What is this product?

### Type

New Capital Multihelvetia is an investment fund under Swiss law of the type "Other funds for traditional investments" pursuant to the Swiss Federal Act on Collective Investment Schemes (CISA) of 23 June 2006.

### Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

### Objectives

The investment objective of New Capital Multihelvetia is mainly to achieve an optimal overall amount. The fund invests a total of at least two-thirds of the fund assets in:

Equities and other equity securities and rights of companies that are either included in the benchmark index (benchmark), have their registered office in Switzerland, as a holding company predominantly hold investments in companies based in Switzerland or have the majority of their economic activities in Switzerland.

The following principles also apply:

The investments mentioned are invested in structured products denominated in Swiss francs (CHF).

The Swiss Performance Index (SPI) serves as a benchmark. The fund manager invests at his own discretion but within the specified investment restrictions.

The fund may use derivatives to control currency and duration.

The fund is suitable for investors with a long-term investment horizon who are primarily aiming for growth of the invested capital.

Including derivatives, the fund management company may invest no more than 10% of the fund's assets in securities and money market instruments from the same issuer. When purchasing securities from an issuer included in the benchmark index, an overweighting of a maximum of 5 percentage points or 125% of its percentage weighting in the benchmark index may be carried out, in deviation from the aforementioned limit of a maximum of 10%. This can result in the fund's assets being concentrated on a few stocks included in the benchmark index, which can lead to an overall risk for the fund that is higher than the risk of the benchmark index (market risk). The investments must be diversified across at least 12 issuers.

The fund's return depends primarily on the development of the stock markets and dividend payments.

The fund's income remains in the fund (reinvestment).

### Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired subject to a test of the investor's financial knowledge and experience.

## What are the risks and what could I get in return?

### Indicator



The risk indicator assumes you keep the product for 5 years.

### What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

Losses are not covered by any investor compensation or guarantee scheme. In addition, in relation to EFG Bank AG, Zürich, which as the Fund's custodian is responsible for the safekeeping of its assets (the "Custodian"), there is a potential risk of default in the event that the Fund's assets held with the Custodian are lost. However, this risk of default is limited as the Custodian is required by law and regulation to segregate its own assets from the Fund's assets. The Custodian shall be liable to the Fund or the Fund's investors for any loss of a financial instrument held in custody by the Custodian or its delegate, unless the Custodian can demonstrate that the loss resulted from an external event beyond its control.

### What are the costs?

## Costs over time

## How long should I hold it and can I take money out early?

### Recommended holding period: 5 Year(s)

The recommended holding period for this product is 5 year(s). This is the holding period we recommend based on the risk and the expected return on the product.
