What is this product?

New Capital Swiss Small and Mid-Cap Future Leaders is an investment fund under Swiss law of the type "Other funds for traditional investments" pursuant to the Swiss Federal Act on Collective Investment Schemes (CISA) of 23 June 2006.

Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The investment objective of New Capital Swiss Small and Mid-Cap Future Leaders is primarily real capital maintenance and to grow the capital in the long term within the framework of the risk profile. The fund invests a total of at least two-thirds of the fund assets in: equities or other equity securities and rights of small and medium-sized companies that are included in the reference index or conduct the majority of their business in Switzerland and have a high level of innovation or quality. The following principles apply additionally: The aforementioned investments are made in structured products denominated in Swiss francs (CHF). SPI Extra TR (SPIEX) serves as a benchmark. The fund manager invests at their own discretion but within the specified investment restrictions. The fund may use derivatives for currency and duration management. The fund is suitable for investors with a long-term investment horizon who are primarily aiming for growth in their invested capital. The fund management company is permitted to invest a maximum of 10% of a sub-fund's assets in securities and money market instruments of any one issuer, including derivatives. When purchasing securities from an issuer included in the benchmark, an maximum overweighting of five percentage points or 125% of its percentage weighting in the benchmark may be carried out, in deviation from the aforementioned limit of a maximum of 10%. This can result in the fund's assets being concentrated on a few stocks included in the benchmark, which can lead to an overall risk for the fund that is higher than the risk of the benchmark (market risk). The investments the fund is primarily dependent on equity market performance and dividend payments. The fund's income remains in the fund (reinvestment).

Intended retail investor

The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. What happens if UBS Fund Management (Switzerland) AG is unable to pay out?
