## What is this product?

#### Type

The Product is a share of the Sub-fund Wellington Credit Income Fund (the "Fund") which is part of the Wellington Management Funds (Luxembourg) III SICAV (the "Umbrella Fund"), an open-ended investment fund with variable capital (société d'investissement à capital variable) of the umbrella type and is authorised under Part I of the 2010 Law and qualifies as UCITS under Article 1. paragraph 2) points a) and b) of the Directive.

## Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

#### **Objectives**

The Fund seeks long-term total returns, with a secondary focus on regular income by primarily investing either directly or indirectly, in assets across a broadly diversified portfolio of credit instruments issued globally.

The Investment Manager will actively manage the Fund, seeking to achieve the objective by allocating its assets across a broadly diversified portfolio of credit instruments from an investment universe which restricts investment in certain industries: fossil fuels, controversial and conventional weapons, tobacco and cannabis.

The Fund will invest primarily in higher yielding sectors of the credit market, such as emerging market debt, high yield debt, but may also invest in other debt obligations deemed to be consistent with the investment objectives of the Fund.

The Investment Manager believes that that higher yielding credit sectors are subject to a variety of pricing inefficiencies. While the Investment Manager believes that valuations ultimately converge to fundamentals, these inefficiencies can lead to prolonged divergences from fundamental value leaving fundamentally attractive sectors underinvested. The Investment Manager believes that a broad, specialist driven fundamental research platform can successfully identify underappreciated investment opportunities arising from these inefficiencies, with the investment process designed to leverage such a broad research platform to help identify and take advantage of inefficiencies more quickly, and to position the portfolio around market inefficiencies as they change.

The investment decision-making process integrates an analysis of fundamental economic themes, top-down sector relative value, and specialist research on individual credit sectors with bottom-up security selection allowing access to a wide range of market opportunities.

The Fund will aim to declare a distribution of between 4%-8% of the Fund's Net Asset Value in USD on an annual basis, dependent on market conditions, however this is not guaranteed. The average duration of the Fund will generally range between 2-6 years. The weighted average credit quality of the Fund will be

investment grade at the time of purchase i.e. above Baa3 by Moody's, BBB- by Standard & Poor's, or BBB- by Fitch. However, the Fund's average credit quality may be below investment grade from time to time as a result of credit downgrades, rating removal, default or in certain market conditions that the Investment Manager deems appropriate.

Derivatives will be used to hedge (manage) risk and/or volatility and for investment purposes (such as gaining exposure to a security, to create leverage and/or a short position). Derivatives will form a significant part of the strategy and will impact performance.

The Fund does not consider a benchmark during portfolio construction or for performance comparison purposes.

The Fund will invest a minimum of 5% of the Fund's net assets in debt issued by companies and organisations that Investment Manager believes are addressing the world's social and environmental challenges in a differentiated way through their products, services and projects, and which are categorised as Sustainable Investments under SFDR.

The Fund will seek to support certain environmental, social and governance (ESG) characteristics by applying several binding restrictions relating to fossil fuels, controversial and conventional weapons, tobacco and cannabis products.

A minimum of 80% of the Fund's net assets will be aligned to the environmental or social characteristics of the Fund.

This Share class will, via derivatives, seek to provide similar performance to the Fund in its base currency by limiting the impact of the movement of exchange rates between the currency of the Share class and the base currency of the Fund.

### Income policy

The Share class will normally pay distributions from income monthly. If the level of income is deemed insufficient, distributions may be paid from capital forgoing potential capital growth and eroding capital, potentially until all capital is depleted.

#### **Dealing Frequency**

Shares can be bought or sold daily in accordance with the Prospectus. The base currency of the Fund is USD.

## Intended retail Investor

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. Investors in the Fund should be prepared to accept, in normal market conditions, a high degree of volatility of net asset value from time to time. The Fund is suitable as an investment in a well-diversified portfolio. Investors in the Fund should be aware that, as set out in the Fund's Distribution Policy, dividends may be declared out of the capital of the Fund.

# What are the risks and what could I get in return?

## What happens if Wellington Luxembourg S.à r.l. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of the insolvency of the Management Company, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

## What are the costs?

#### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. ## How long should I hold it and can I take money out early?

## Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years.

The Management Company shall redeem shares of this Fund at the redemption price on each dealing day. Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per share of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
