What is this product?

The Product is a share of the Sub-fund Wellington Next Generation Global Equity Fund (the "Fund") which is part of the Wellington Management Funds (Luxembourg) III SICAV (the "Umbrella Fund"), an open-ended investment fund with variable capital (société d'investissement à capital variable) of the umbrella type and is authorised under Part I of the 2010 Law and qualifies as UCITS under Article 1. paragraph 2) points a) and b) of the Directive.

Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

Objectives

The Fund seeks long-term total returns in excess of the MSCI All-Country World Index ("Index"), primarily investing in companies that the Investment Manager believes are positioned to benefit from themes relating to the next generation of structural changes and economic development in global developed and emerging markets.

The Fund invests in companies the Investment Manager believes are positioned to benefit from themes relating to the next generation of structural changes and economic development in global developed and emerging markets. The Investment Manager seeks to identify investment opportunities which both align with the UN Sustainable Development Goals ("UN SDGs") and reflect the following long-term environmental and social themes: Innovation; Sustainability; Inclusion.

The Index serves as a reference benchmark for performance comparison purposes. Whilst Fund securities may be components of the Index, the Index is not considered during portfolio construction and the Investment Manager will not manage the extent to which Fund securities differ from the Index. The Index is designed to measure the performance of the global developed and emerging markets. The Fund will invest in shares and other securities with equity characteristics such as preferred stocks, convertible securities or depository receipts. The Fund may invest either directly or via derivatives.

While there are no restrictions on the Fund's ability to use derivatives for investment purposes (such as gaining exposure to a security), derivatives are mainly used to hedge (manage) risk.

Although the Fund does not have a specific sustainable investment objective, the Investment Manager supports certain environmental and social characteristics:

-The Fund will invest least 75% of the Fund's net assets in companies considered Sustainable Investments

• The Fund will not invest in companies either involved in the mining of thermal coal or that receive >25% revenue from thermal coal energy generation

A minimum of 75% of the Fund's net assets will be aligned to the environmental or social characteristics of the Fund.

Income policy

Any income allocated to the Share class from the Fund is reinvested.

Dealing Frequency

Shares can be bought or sold daily in accordance with the Prospectus.

Intended retail Investor

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. Investors in the Fund should be prepared to accept, in normal market conditions, a high degree of volatility of net asset value from time to time. The Fund is suitable as an investment in a well-diversified portfolio.

What are the risks and what could I get in return?

Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per share of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
