What is this product?

Type

The Product is a share of the Sub-fund Wellington Global Innovation Fund (the "Fund") which is part of the Wellington Management Funds (Luxembourg) III SICAV (the "Umbrella Fund"), an open-ended investment fund with variable capital (société d'investissement à capital variable) of the umbrella type and is authorised under Part I of the 2010 Law and qualifies as UCITS under Article 1. paragraph 2) points a) and b) of the Directive.

Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

Objectives

The Fund seeks long-term capital appreciation.

The Fund will be actively managed in excess of the MSCI All Country World Index (the "Index"), primarily investing in equity securities issued by companies worldwide including emerging markets, that the Investment Manager believes have the potential to create new or disrupt existing industries and structural growth opportunities independent of global growth and the economic cycle, focusing on companies that identify areas of innovation and high potential for growth within their industries. The Fund considers the impact of macroeconomic trends, such as consolidation, regulation and industry convergence, that can influence future investment returns. The investment strategy for the Fund focuses on a long time horizon (up to 10 years) as many of the investment themes may take time to develop.

The Fund will invest in shares and other securities with equity characteristics such as preferred stocks, depository receipts and REITS. The Fund may invest either directly or via derivatives.

Derivatives may be used to hedge (manage) risk and for investment purposes (such as gaining exposure to a security).

The Index serves as a reference benchmark for performance comparison and weighted average carbon intensity purposes. Whilst Fund securities may be components of the Index, the Index is not considered during portfolio construction and the Investment Manager will not manage the extent to which Fund securities differ from the Index.

The Fund will seek to support certain environmental and social characteristics and will abide by the following binding restrictions:

- The Fund will maintain a weighted average carbon intensity that is at least 25% lower than the Index.

- The Fund aims to promote gender diversity in board representation by investing at least 33% of the Fund's net assets in companies with three or more women on their board.

A minimum of 80% of the Fund's net assets will be aligned to the environmental or social characteristics of the Fund.

The currency of this Share class is different to the base currency of the Fund and so the performance of the Share class will be subject to the impact of the movement of the exchange rate between the currencies.

Income policy

Any income allocated to the Share class from the Fund is reinvested.

Dealing Frequency

Shares can be bought or sold daily in accordance with the Prospectus. The base currency of the Fund is USD.

Intended retail Investor

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. An investment in the Fund should not constitute a substantial proportion of an investment portfolio and may not be appropriate for all investors.

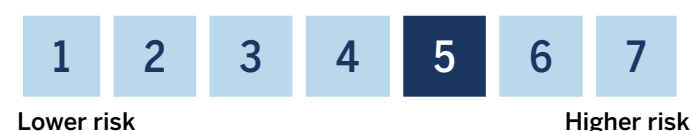

What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 5 years.

Performance Scenarios

What happens if Wellington Luxembourg S.à r.l. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of the insolvency of the Management Company, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the 5 year holding period we have assumed the product performs as shown in the moderate scenario

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years.

The Management Company shall redeem shares of this Fund at the redemption price on each dealing day. Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per share of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
