What is this product?

Type: Shares of a Sub-Fund of ASB AXION, an Undertaking for Collective Investments in Transferable Securities (UCITS), established as a SICAV.

Term: The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: The main objective of the Kermata Fund is to generate reasonable income over the recommended holding period by means of investing predominantly in European centered bonds and money market instruments.

In order to achieve this objective, the Kermata Fund may invest in fixed and floating rate debt securities of corporate, governmental and semigovernmental issuers worldwide, including issuers from Emerging Markets Countries and issuers with a rating below investment grade. The relevant debt securities can be acquired either directly or through the investment in other investment funds, including UCITS, other UCIs and exchange traded funds.

The Sub-Fund may also acquire warrants on such debt securities. The Kermata Fund may invest up to 20% of its assets in structured products such as asset-backed securities, mortgage-backed securities and capital protected products.

Depending on the market environment, up to 100% of the Kermata Fund's net assets may be held in liquid assets, such as cash deposits and money market instruments. Financial derivative instruments, including futures, options and swaps on eligible underlyings, may be used both for efficient portfolio management and hedging purposes. Debt securities of issuers from Emerging Market countries shall not exceed 49% of the total net assets of the Sub-Fund. Debt securities from issuers with a rating below investment grade shall not exceed 25% of the total net assets of the Sub-Fund. Units of other UCITS or UCIs (including ETFs) shall not exceed 50% of the total net assets of the Sub-Fund. The Kermata Fund shall not invest in other UCITS or UCIs levying a management fee of more than 2.5%.

Benchmark: The Sub-Fund is actively managed and is not managed in reference to a benchmark.

The Sub-Fund integrates Sustainability Factors in its investment process and takes into account principal adverse impacts of investment decisions on Sustainability Factors as outlined in more detail in section "Sustainable Investment" of the Prospectus.

This is a non-distributing share class. Investment income is re-invested.

The minimum recommended holding term is 1 year.

Investors may sell on demand on any business day in Luxembourg.

Intended Retail Investor: This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds seeking to increase the value of their investment and to receive income over the recommended holding period with the ability to bear losses up to the amount invested.

Redemption and Dealing: Shares may be sold (redeemed) as stated in the prospectus at the respective dealing price (net asset value). Further details are provided in the ASB AXION prospectus.

Distribution Policy: As this is a non-distributing share class, investment income is reinvested.



What are the risks and what could I get in return?

RISK INDICATOR



The risk indicator assumes you keep the product for 1 year.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movement in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Additional risks: Market liquidity risk could amplify the variation of product performances.

This product does not include any protection from future market performance so you could lose some or all of your investment.

What happens if Amundi Luxembourg S.A. is unable to pay out?

A separate pool of assets is invested and maintained for each Sub-Fund of ASB AXION. The assets and liabilities of the Sub-Fund are segregated from those of other sub-funds as well as from those of the Management Company, and there is no cross-liability among any of them. The Sub-Fund would not be liable if the Management Company or any delegated service provider were to fail or default.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, and how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (O % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
- CHF 10,000 is invested.
