## Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

## What is this product?

**Type** The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

### Objectives

**Product objectives** The investment objective of this Fund is to achieve capital appreciation through investment in a portfolio of equity securities. In addition, the Fund has sustainable investment as its objective.

**Investment approach** The Sub-Investment Manager aims to create a global equity portfolio focused on companies aligned with the transition to a regenerative economy and climate transition goals. The investment strategy focuses on companies with forecasted emissions consistent with a Net Zero approach and activities deemed environmentally sustainable. The selection process includes negative screening and assessments of pathway quality, transition moat, and bottom-up validity. The portfolio is weighted across seven transition sectors and adjusted based on financial risk considerations. The Fund has a sustainable investment objective and integrates sustainability risks while expecting 0% investment in EU Taxonomy-aligned activities as of the supplement date.

**Investment policy** The Fund primarily invests in equities worldwide listed on recognized markets, including emerging markets. It may gain exposure of less than 30% to China A shares through direct investments, participatory notes, or other collective investment schemes. The Fund may also invest in open-ended and closed-ended collective investment schemes, subject to UCITS eligibility criteria. In certain circumstances, the Fund's assets may be invested in Money Market Instruments, cash deposits, or debt instruments issued or guaranteed by various entities, as per investment restrictions.

**Benchmark** The investment performance of the Fund will be measured against MSCI ACWI Index (USD) which captures large and mid-cap representation across both developed and emerging market countries. The Fund is actively managed and as such does not seek to replicate its benchmark index, but instead may differ from the performance benchmark in order to achieve its objective. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities

**Redemption policy** Shares in the Fund can be bought and sold daily (every Business Day of the Fund). Shareholders may request the repurchase of shares on any Redemption Day through various communication methods, and such requests are generally irrevocable unless otherwise approved. Redemption requests are subject to certain conditions, including the completion of necessary documentation and compliance with anti-money laundering procedures. Redemption fees will not be levied by the Company,

however charges of this nature may be levied by third party nominees, distributors or intermediaries.

**Distribution policy** Accumulating shares do not pay dividends. The annual result is capitalized (or reinvested). Income shares pay a dividend, insofar as the performance of the fund allows.

**Exchange policy** Subject to the conditions set down in the Prospectus, you are entitled to switch from one share class to another, either in the Fund or in another sub-fund of the Company. Please refer to the Prospectus for further information on how to switch.

**Asset segregation** The Fund is a sub-fund of the Company, an umbrella fund with segregated liability between sub-funds. You can find out more information about the umbrella fund in the Prospectus.

### SFDR Article 9

**Derivatives policy** The Fund does not intend to use financial derivative instruments (FDIs) for investment purposes but may utilize forward foreign currency exchange contracts for hedging. The global exposure of the Fund from using financial derivative instruments is limited to the Net Asset Value, and derivatives are expected to be used solely for hedging purposes. The Company has a risk management process in place to monitor and manage risks associated with FDIs.

**Intended retail investor** The Fund is suitable for investors seeking capital growth over a long time horizon with a high level of volatility commensurate with a portfolio of high growth companies in emerging markets.

**Term** The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. Waystone Management Company (IE) is not entitled to terminate the product unilaterally. The Company may repurchase all shares at the determined repurchase price on the specified redemption day by providing shareholders with a notice period of four to twelve weeks.

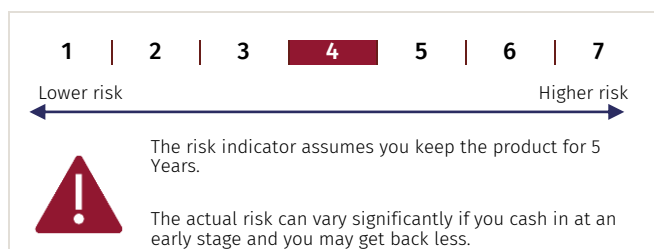

#### What happens if Waystone Management Company (IE) Limited is unable to pay out?

The Management Company of the Fund has no obligation to pay out since the Fund design does not contemplate any such payment being made. You are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depository. Should the Fund default, the depository would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

#### Costs over time

#### How long should I hold it and can I take my money out early?

##### Recommended holding period: 5 Years

This product is designed for longer term investments; you should be prepared to stay invested for at least 5 Years. However, you can redeem your investment without penalty at any time during this period, or hold the investment longer. Redemptions are possible on every working day; it will take 3 working days for you to be paid. The price per share for the day, based on the actual value of the Share Class, is set each day at 23:00 hours (Irish time).
