## What is this product?

### Type

UBS (CH) Select Money Market Fund is a contractual umbrella fund (short-term money market fund pursuant to the SFAMA Guidelines for Money Market Funds) of the type "Other funds for traditional investments" pursuant to the Swiss Federal Act on Collective Investment Schemes (CISA) of 23 June 2006.

### Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

### Objectives

The investment objective of the actively managed subfund is primarily to achieve long-term performance consistent with the development of the prevailing market indices for money market instruments denominated in US dollars (USD).

The subfund invests primarily in money market instruments denominated in US dollars from countries, other public bodies or private borrowers worldwide that have been classified as first-class. Furthermore, this subfund invests in other investments permitted under the fund contract. The average maturity of the securities in the portfolio may not exceed 1 year.

The subfund uses the benchmark as a reference for comparing performance. In times of high market volatility, the performance of the subfund can deviate significantly from the benchmark.

The return of the fund depends primarily on the development of interest rates, the creditworthiness of issuers and interest income. Income of this share class is reinvested.

### Intended retail investor

This fund applies to retail investors with a basic financial understanding. The fund is aimed at preserving the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund is only suited to be acquired within a discretionary mandate.

### What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

## What are the costs?
