What is this product?

Type

"Zurich Invest II" is a contractual investment fund governed by Swiss law of the type "Other funds for traditional investments" pursuant to the Swiss Federal Act on Collective Investment Schemes (CISA) of 23 June 2006 with several sub-funds (umbrella structure).

Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

Objectives

As an umbrella fund, the fund indirectly invests between 35% and 55% of its assets in equities, between 45% and 65% in debt securities and up to a maximum of 10% in real estate. The objective of the sub-fund ("fund") is to produce steady capital growth by means of a balanced risk strategy. It seeks to achieve this by investing indirectly in equities and debt securities. The fund has various share classes. These can vary in terms of their level of commission, minimum investment, currency, distribution or reinvestment of income and investor qualification requirements.

The return of the fund depends primarily on the performance of the capital markets. The following factors play a part in this to a greater or lesser extent: performance of equity markets and dividends, interest rates, the creditworthiness of the issuers of the selected instruments and interest income. The return may also be affected by currency fluctuations where active or unhedged positions exist. The fund's income is reinvested in segregated funds after the end of the financial year (reinvestment).

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

What are the risks and what could I get in return?

Indicator

What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

What are the costs?

Costs over time
