What is this product?

Type : Flexible fund, Income Accumulation

Objectives : This Fund is actively managed and aims to maximize capital with focus on companies subject to extraordinary/special situations such as mergers, acquisitions and restructuring with the aim to take advantage of such events.

Investment Policy: This objective will be reached by investing mainly in transferable securities, particularly equities and bonds, money market instruments and derivatives (such as futures and options, Contracts for Difference or Equity Swaps), in order to create long and short exposure with the aim of exploiting potential opportunities. The Fund has no reference Benchmark. If the Fund invests in Swaps on Indexes, the index composition will be public and disciplined by appropriate Index Rules publicly available and in accordance with the provisions of the Law in any case, the Fund will not invest in derivatives where the counterparties have any discretion on the composition or management of the Fund's investment portfolio or on the underlying of the financial derivative instruments. In particular, in order to realize its investment strategy, the Fund may:

- hold liquid assets, including cash, bank deposits, money market instruments or units of Undertakings for Collective Investments in Transferable Securities (UCITS) and/or other Undertakings for Collective Investments (UCIs) that have a policy of investing mainly in liquidity strategies on a residual basis (less than 50% of its net assets)
- invest up to 100% of its net assets in various issues (minimum 6) of securities and money market financial instruments, issued or guaranteed by a Member State of the European Union, by its public territorial authorities, by a Member state of the OECD, by international public institutions to which one or more EU Member States belong. The Fund will invest mainly in developed markets
- invest up to 10% of its net assets in units of other UCITS or other UCIs
- use financial techniques and instruments in order to promote efficient portfolio management. The Fund's value is calculated and expressed in Euros.

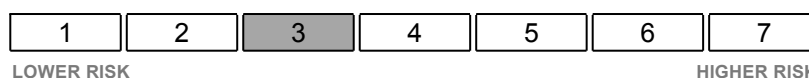
Redemption: Unit holders may request redemption of the units at any time by sending an irrevocable redemption instruction to the Depositary Bank, to the Management Company, to the other banks or other institutions authorised for this purpose by the Management Company accompanied by subscription confirmations or certificates representative of units, as the case may be. Redemption lists are closed at the registered office of the Management Company by 10 a. m. two banking days prior to the Calculation Date.

Maturity : The Fund is established without limits of duration

Intended retail investor : This Sub-Fund is reserved to institutional investors. The investor is warned that all investments involve a percentage of risk and that it cannot be guaranteed that investment policy objectives will be achieved. The minimum amount of the first subscription is EUR 2,000,000. No minimum amount for subsequent subscriptions.

What happens if Ersel Gestion Internationale S.A. is unable to pay out?
